Christmas Tree Disposal

Please see the tips below about how to properly dispose of your Christmas tree:

Compostable Christmas Treecycling and Non-compostable Tree Disposal Options

(For San Pablo, Hercules, Pinole, Unincorporated West County, Crockett-Tormey-Port Costa, Rodeo)

 Curbside Collection:

 On any of your regular organic waste collection days, cut your unflocked, natural tree to fit in your organic waste cart. Trees must be 6" or less in diameter and cut to 3' in length. Remove stand and all decorations. Artificial, flocked, cart. Trees must be 6" or less in diameter and cut to 3' in length. Remove stand and all decorations. Artificial, flocked,

 ornament contaminated trees are not compostable. Cut or trim to fit in brown trash container and set out on any regular trash collection day.







IMPORTANT GUIDELINES FOR COMPOSTING CHRISTMAS TREES-PLEASE:

- ents, tinsel, nails and stands
- No flocked, painted, fireproofed, artificial or trees contaminated with decorations, stands, or plastic or cloth









2. On-call Bulky Pick-up: San Pablo, Pinole, and Unincorporated West County and Crockett residents: if you've

not already used your allocated On-Call Curbside Bulky Clean-up(s), call our Customer Service office to arrange for curbside pick-up (costs may vary by communities). Trees 6' tall or more must be cut in half.



3. *For Fee Curbside Collection:*If you're unable to cut/trim your compostable tree to fit in your organic waste container or non-compostable tree (artificial, flocked, contaminated with ornaments, stands, plastic, cloth wrapped) in the brown container, call our Customer Service office to arrange "For Fee" curbside collection (approximately \$18.10/tree). On-Call and "For Fee" pick-ups must be scheduled in advance—call 510.262.7100.



 Self-haul (Drop-off):
 With proof of residency (driver's license or CA ID), Republic Services customers can take Christmas Trees to Golden Bear Transfer (#1 Parr
 Blvd, Richmond M-F, 7am-5pm; Sat-Sun, 9am-5pm) thru the 1st weekend in February at no cost for compostable trees; approximately \$12.50 (subject to change) disposal fee for non-compostable trees, of no proof of residency.

Senior Services Update

While the Hercules Senior Center is generally closed due to the COVID-19 Pandemic, the following services are available to Seniors through our Senior Center: weekly meal services through CC Café (pick-up every Tuesday) consisting of 5 frozen meals, a loaf of bread and a gallon of milk; the Contra Costa Food Bank comes out on-site the first and third Tuesday of each month bringing fresh fruits and vegetables; the Hercules senior center also acts as a location for Meals on Wheels service Tuesday through Thursday; we hold a blood drive with American Red Cross quarterly; Senior Center staff and volunteers staff do a wellness check with all the Senior Center members (about 200) on a monthly basis; and we are holding virtual zoom classes routinely (Line Dance/Hula/Tai Chi). We also make referrals for tax assistance, food and groceries, and other programs, though and now most referrals are to the Hercules Cares nonprofit group which will assist Seniors with getting prescriptions filled, picking up food, laundry, and whatever is needed.



Planning Commission

Due to a lack of agenda items, the regular meetings of the Planning Commission on December 7, December 21, and January 4 were cancelled. The next regular meeting of the Planning Commission is scheduled for Tuesday, January 19 (due to the Martin Luther King Jr. holiday on Monday, January 18), though there are no agenda items currently scheduled.

PUBLIC WORKS DEPARTMENT

Maintenance & Operations

Staff completed their regularly scheduled custodial and facility-related tasks in public parks, buildings, and sewer lift stations. They cleaned up numerous illegal dumping, removed fallen debris from trees, repaired streetlights throughout town, and replaced street signs at miscellaneous locations. The Engie Energy Generation and Conservation Project completed 80% of the lighting retrofits in City facilities and replaced approximately 500 streetlights with energy-efficient LED lights.

Engineering

Construction continues on the future Safeway, located at the southeast corner of San Pablo and Sycamore Avenue, and the grading work is on-going at the Willow Storage Project. The public improvements are underway for the Bayfront Development Blocks Q&R while the plans were completed for the associated abandonment of the terminus of Linus Pauling. The design plans are also under review for Sycamore Crossing. Design is underway for the mile-long segment of replacement sewer trunk main leading into the Pinole-Hercules Water Pollution Control Plant. The financial study for the sewer fund is nearing completion. Design on the Regional Intermodal Transportation Center (RITC) is advancing. The 90% design work was completed for the Sycamore Avenue Resurfacing Project, which is scheduled for construction in Summer 2021. The Santa Clara Valley Housing Group is preparing a parcel map, mass grading, and phasing plan for the Hilltown development.

<u>Identity Theft:</u> On December 21, 2020, at approximately 8:44 am, an Officer handled a lobby detail for an identity theft. A Hercules resident reported she was checking her credit report and discovered someone had fraudulently opened a credit account, in her name, without her permission and there was now a balance on the account.

<u>Domestic Violence Restraining Order Violation:</u> On December 21, 2020, at approximately 10:23 am, an Officer handled a phone detail for a court order violation. A 25 year old female, Hercules resident, received text messages from the 34 year old father of her child. There were several threatening messages regarding their child. There is a Domestic Violence restraining order

protecting victim from any contact by the male. The order is valid through July 24, 2027.

Shoplifting/Battery: On December 21, 2020, at approximately 2:49 pm, HPD Officers were dispatched to Rite Aid for a theft which just occurred. The suspects were described as a male, and female, adult. They were seen leaving the area in a white Hyundai on Sycamore towards Civic Drive. One of the suspects threw a burrito at the store clerk and hit him in the chest. An Officer stopped a white Hyundai on Sycamore eastbound in between Redwood and Lupine. The 26 year old male driver, and 24 year old female passenger, matched the description of the suspects and were detained. The male was on Felony probation, out of Napa County, for theft. The merchandise taken from Rite Aid was located in the vehicle and returned to Rite Aid. The store clerk positively identified the female as the person who stole merchandise; and stated the male threw the burrito at him. The female was issued a citation for shoplifting; and the male was issued a citation for battery. Both subjects were released at the scene.

Domestic Battery/Child Endangerment: On December 21st at 10:56 PM, officers were dispatched to the 1200 block of Willow Ave for a cold battery that occurred during a child custody exchange. The child's 35 year old father shoved the child's 30 year old mother leaving no injuries. The child was present for the battery. The male was not on scene and an unserved Emergency Protective Order was granted.

<u>Vehicle Vs Pedestrian Collision:</u> On December 22, 2020, at approximately 5:36 pm, HPD Officers were dispatched to a collision, involving a pedestrian, at Newbury and Canterbury. Officers located a 32 year old female, sitting on the west curb on Newbury, with a minor head and right elbow injuries. The female was crossing Newbury, in a westbound direction from the park, and was struck by a 2018 Honda Civic. The Civic was driven A 66 old female. The driver was turning south onto Newbury from Canterbury and hit the pedestrian as she was crossing the street. The pedestrian was transported, by ambulance, to a local hospital.

<u>Domestic Battery:</u> On December 23, 2020, at approximately 8:35 am, HPD Officers were dispatched to the 100 block of Copper Beech Glen for a welfare check. The reporting party was calling from out of state and said her 41 year old daughter was in trouble. Officers arrived, at the Copper Beach address, and contacted the female and her 42 year old husband It was determined there was an argument and both parties pushed each other. The male agreed to leave the residence. There were no visible injuries on either party and neither party wanted to press charges. A case was taken.

Evading: On December 24, 2020 at 1:14AM HPD Officer were notified of a Automated License Plate Reader hit on a carjacked red 2017 Mitsubishi Outlander. A HPD Officer located the vehicle in the 800 block of Willow Ave. A high risk stop was attempted but the driver fled from Officers. The pursuit was terminated when the vehicle began to drive westbound in the eastbound lanes of Hwy 4.

Found Property: On December 24, 2020 at 11:58 am an officer conducted a traffic stop on a 1995 Buick for expired registration. The 41 year old male driver was found to be on Parole for Carjacking. There was a 40 year old female passenger in the vehicle, out of Vallejo. There was a BB gun located under the driver seat which was said to belong to the female's sons. There was a credit card machine in the trunk. Neither party said they knew about the credit card machine and

denied ownership. The credit card machine and the BB gun were taken as found property.

<u>Theft from Vehicle:</u> On December 24, 2020 at 4:29 pm, an officer was dispatched to the 100 block of Oarsman Ct for a theft from an unlocked vehicle. The victim stated, sometime between Tuesday December 22, 2020 at 5:00 pm and the time of call, an unknown suspect stole items from his unlocked vehicle.

The Reporting Party stated his neighbors Toyota Prius was on jacks and suspects stole the catalytic converter. Officers determined the suspect vehicle was a Silver Honda Odyssey with no plates.
