Smoking Restrictions Information

Effective July 1, 2020, the City's non-smoking ordinance become effective for multi-family ownership units in buildings with 10 or more units. After the effective date, the City sent notification to all impacted units and the Homeowners Associations in which these units were located - over 450 owners and tenants of buildings with 10 or more units in the Devonwood, Glenwood, and Railroad Avenue live–work communities. The City has also updated its website with information on the ordinance and resources regarding smoking and that can be found here: https://www.ci.hercules.ca.us/government/building/code-enforcement/smoking-prohibitions. The City Council will also be getting an update on the smoking ordinance at their January 26th meeting.

Changes Coming to City Council Public Comment Process

Since March last year, given the COVID Pandemic, City Council meetings have been conducted utilizing the Zoom platform, and under the Governor's Executive Order which suspended elements of the Brown Act, public comment has been limited to written comments submitted via e-mail and read by the City Clerk. As we continue to navigate the Pandemic and these restrictions, the City Council requested we explore an alternative method for public comment which would allow those with public comment to join the Zoom meeting and make their public comments "live." Staff is working to make this possible and hope to have that live for Tuesday, January 24th. Please check out the agenda cover page for more detailed information about how to access the meeting via Zoom. Given this change, public comments submitted in writing will no longer be read, but will be provided to the City Council in written form. If you have public comments which you wish to share with the City Council, please be sure to plan to join the Zoom meeting. A staff member will be monitoring the Zoom meeting and will "admit" public comments who are queued up individually to the meeting for the three minutes available for their public comment.

Plastic Bag Ban Annual Reports from Businesses

In March 2015, Ordinance 480 became effective in Hercules which banned the use of plastic bags. Each year, local businesses are required to complete a report for their prior calendar year regarding their compliance. Letters have been sent out to local business reminding them that their reports are due by February 15th.

Planning Commission

At its **meeting on Tuesday, January 19**, the Planning Commission welcomed newly appointed Commissioner Robert Schaufenbil and appointed Commissioner Hector Rubio as Chair and Commissioner Ken Morrison as Vice Chair.

At its next regular meeting on Monday, February 1, the Planning Commission will:

• Hold a public hearing to consider approving Conditional Use Permit (CUP #21-01) to add on-site sale and consumption of alcohol (including beer, wine, and spirits) at Ahn's Kitchen, an existing 1,140-square-foot restaurant at 844 Willow, Suite "A3" within the Willow Avenue shopping center in Hercules, CA. The restaurant is in a General Commercial (CG) zone, whereby restaurants with liquor service are allowed with approval of a conditional use permit.

PUBLIC WORKS DEPARTMENT

Maintenance & Operations

Staff completed their regularly scheduled custodial and facility-related tasks in public parks, buildings, and sewer lift stations. They cleaned up numerous illegal dumping, repaired street lights throughout town, repaired a water leak at Foxboro Community Center, cleared drains at Hanna Park restrooms, and cleaned bird droppings around the Gazebo area in Refugio Park. For the Energy Generation and Conservation Project, Engie Inc. prepared to start the HVAC upgrades.

Engineering

Construction continues on the future Safeway, located at the southeast corner of San Pablo and

Sycamore Avenue, and the grading work is on-going at the Willow Storage Project. The public improvements are underway for the Bayfront Development Blocks Q&R while the plans were reviewed for the associated private stormwater facility. The design plans are also under review for Sycamore Crossing development project. The improvement plans reached 90% completion for the mile long segment of replacement sewer trunk main leading into the Pinole-Hercules Water Pollution Control Plant and construction management firms were interviewed for oversight of the work, once underway. The financial study for the sewer fund is nearing completion. Design on the Regional Intermodal Transportation Center (RITC) is advancing. The Santa Clara Valley Housing Group is preparing a parcel map, mass grading, and phasing plan for the Hilltown development and submitted fees to begin the plan check process.

Felony Ramey Warrant Arrest/False Personation of Another/Felon in Possession of a Firearm/Towed Vehicle: On January 11, 2021 at 4:00 a.m. An Officer did a traffic stop on a Gray '08 Nissan Titan truck (Paper Plates) on N/B Willow Ave, for lighting and registration violations. The registration expired as of May 2019. The 35 year old male driver verbally identified himself, and said he lived in Antioch. A 26 year old female friend, out of Oakland, knocked on the door and window of the residence broke the front window to the victim's residence. The victim wished to press charges against for the vandalism. The suspect was arrested, cited, and released. The wallet was returned.
