# **CITY MANAGER'S OFFICE**

### **Good News from the City Council!**

At its meeting last Tuesday night, the City Council

- **Discussed its choice for a new city manager.** The Council interviewed several highlyqualified candidates for the position late last week and is optimistic that it will soon introduce Hercules' next city manager to the community.
- **Passed a \$48M expenditure budget.** At the last of three public hearings on the annual budget, the Council passed the resolutions necessary to fund the City over the next twelve months, starting July 1. Service levels will remain roughly the same as they have over the past few years, but there were a few notable budget items that community members might be interested in, including:
  - **Library**: The Library will be open 46 hours per week.
  - **Fireworks**: The Council added funding for a fireworks show to celebrate the Fourth of July not this year, but in 2022.
  - **Swingsets**: The Council added money in the budget to purchase a set of swingsets that will be accessible to people with disabilities.
  - **Corporation Yard Landscaping:** After receiving suggestions that the City's corporation yard on Sycamore Avenue could benefit from some landscape screening, the Council added money to do so.
- Hired a Consultant to Help With the American Rescue Plan Act (ARPA) Funding. The Federal Government, in its effort to get the nation back on its feet after the COVID pandemic, is sending cash directly to cities. Hercules will receive about \$6.2M, and generally speaking, as the rules are currently written and understood, the City will be able to use it to cover costs incurred for responding to the COVID-19 pandemic; addressing the negative economic impacts on local businesses and nonprofits; and making investments in water, sewer, and broadband infrastructure. Because the rules for spending the money are subject to interpretation, Hercules has retained a consultant to help the City understand how the money can be spent and develop an expenditure plan. That said, at this time, and given staff's current understanding of the rules, some specific purposes that Hercules might use the funds for include:
  - Retrofitting city-owned buildings to reduce the spread of the virus.
  - Cash and loan investments to businesses impacted by the pandemic.
  - Programs that benefit disadvantaged people who were impacted by the pandemic.
  - $\circ$  Cash and loans to support housing, including the acquisition of affordable housing.
  - Projects, programs, and building renovations that support childcare and education and, in so doing, allow parents to return to their workplaces.

Stay tuned over the next few months as the City Council makes big decisions regarding where the City's \$6.2M ARPA funds should and will be spent!

# Get Ready for Reopening with a Visit from the CCHS Vaccine Van





On June 15 the state will <u>relax its pandemic health</u> <u>guidelines</u> affecting businesses and community activities – but face masks will still be required in most indoor public places for people who are not fully vaccinated. If your workplace or group wants to fully enjoy the summer reopening, but not everybody has had the opportunity to get a vaccine, now is a great time to schedule a visit from Contra Costa Health Services' (CCHS) new mobile vaccination service.

The COVID-19 vaccine van will visit your location within the county to provide safe, effective vaccinations at no cost to you.

At least five vaccine-eligible members of your group must agree to use the service during the visit, but county residency is not required and there is no limit to the number of people who can get a vaccine.

Vaccine is the best protection we have against COVID-19, and more than 76% of Contra Costa residents who are 12 or older have gotten at least one dose so far – more than 754,000 people, and nearly 1.4 million doses in all.

Use the online form to request a visit. CCHS will work with you to schedule a time Monday

through Friday between 8 a.m. and 3 p.m., within one week of your request.

#### PUBLIC WORKS DEPARTMENT



#### Maintenance & Operations

Staff completed their regularly scheduled custodial and facility-related tasks in public parks, buildings, and sewer lift stations. They cleaned up numerous illegal dumping, repaired streetlights, and removed litter on roadways. Engie continues to advance the Energy Generation and Conservation Project. They are currently working on the HVAC upgrades and finishing the solar arrays. Preparations are being made for the Household Hazardous Waste event scheduled for Saturday at the Corporation Yard, the railings on Sanderling and Sycamore are being restored, and cabinets are being built at the Lupine Child Care facility.

#### Engineering

The public improvements are underway for the Bayfront Development Blocks Q&R including sidewalks, loop road and the abandonment of Linus Pauling. The design plans are also under review for the Sycamore Crossing development project, including the EBMUD relocation of the waterline into San Pablo Avenue and hotel. The improvement plans reached 100% completion for the mile long segment of replacement sewer trunk main leading into the Pinole-Hercules Water Pollution Control Plant and the project will be bid out shortly, once permits are received from regulatory agencies. Design on the Regional Intermodal Transportation Center (RITC) is advancing utilizing \$1.2M in grant funding while the Turquoise Rehabilitation Project is out to bid. Plan check is underway for private development projects including the Hilltown development, Franklin Canyon RV Park, America's Tire Store, and theWillow Storage Facility. The Civic Drive/Sycamore Avenue Pedestrian Enhancement Project is under construction.
