**Contra Costa County Health Services COVID-19 Vaccine Update**

**Children Ages 5-11 Now Eligible for COVID-19 Vaccines**

Nov. 3, 2021: Federal and state health officials have approved Pfizer's COVID-19 vaccine for children ages 5-11, paving the way for an additional 92,000 county residents to get immunized.

Initial demand for the pediatric COVID-19 vaccine is expected to be high as eager parents seek protection for their children. Parents and caregivers should check with their child's regular healthcare provider or local pharmacies about availability.

Parents and caregivers can schedule appointments for kids ages 5-11 at county-run vaccination sites starting in the afternoon of Thursday, Nov. 4.

The pediatric COVID-19 vaccine is one-third the dosage given to teens and adults and smaller needles will be used. Like with adults, children ages 5-11 still must get two shots at least three weeks apart to get the maximum protection of the vaccine.

### Planning Commission

At its regularly scheduled meeting on **Monday, November 15**, the Planning Commission is scheduled to:

- Hold a public hearing to consider Conditional Use Permit #21-04 to allow **Everest Grocery, a new 1,200 square-foot-grocery market specializing in Nepali, Indian, Tibetan, Bhutanese, Pakistani, and South Asian grocery items, at 844 Willow Avenue, Unit A5.** The grocery market’s hours of operation would be 10:00 a.m. to 8:00 p.m., seven days a week. The applicant expects to employ three (3) to four (4) full-time employees.

- Consider recommending to City Council **parcel map MS #478-21 to subdivide the Safeway Center into three parcels.**

### **City Council**

At its regular meeting on **November 9**, the City Council :

- **Approved Minor Modification #21-03 for the Safeway Center, located at the northeast corner of the intersections of Sycamore Avenue and San Pablo Avenue in Hercules (4080 San Pablo Avenue).** Modifications to the previously approved site plans and designs include:
  - Replace bike lockers with bike racks;
  - Plant hedges along the east edge of the property in lieu of trees along the east and north edges of the property due to existing underground gas line, retaining wall, and limited space;
  - Relocate two trees at northwest corner of the property;
  - Remove hanging plants on lights poles; and
  - Add designated areas for outdoor sales and displays.
- Adopted a **resolution to vest certain entitlement rights for the Sycamore Crossing project.**

### **PUBLIC WORKS DEPARTMENT**



### **Maintenance & Operations**

Staff completed their regularly scheduled custodial and facility-related tasks in public parks, buildings, and sewer lift stations. They cleaned up numerous illegal dumping, repaired streetlights, removed litter on roadways, and responded to sanitary sewer overflow. Engie is nearing completion on the Energy Generation and Conservation Project. They are currently working on

the last item of work, which is the library HVAC upgrades. Staff is inventorying street signs for replacement on private streets. The shipment of the replacement streetlights in the Gems & Birds neighborhoods has been delayed until early December due to supply chain issues. Leaf season is in full effect and the annual catch basin cleaning is underway. Staff is installing new cabinets in the Lupine Child Care facility. The annual tree trimming contract was put out to bid and the annual striping contract was awarded.

### **Engineering**

The design plans are under review for the Sycamore Crossing development project, including the EBMUD relocation of the waterline into San Pablo Avenue and hotel. The improvement plans reached 100% completion for the mile long segment of replacement sewer trunk main leading into the Pinole-Hercules Water Pollution Control Plant and the project will be bid out once permits are obtained from regulatory agencies. Design on the Regional Intermodal Transportation Center (RITC) is advancing utilizing \$1.2M in grant funding. Plan check is underway for private development projects including Franklin Canyon RV Park, America's Tire Store, and the Willow Storage Facility. The Civic Drive/Sycamore Avenue Pedestrian Enhancement Project is nearing completion. Construction continued on the Turquoise Avenue Rehabilitation Project while design is nearing completion for the Sycamore Avenue Rehabilitation Project, which is scheduled for the Summer. The peer review process is underway for the Palm/Willow Sidewalk Project, a necessary step to receive the \$1M grant, and the project is tentatively scheduled for construction this Summer.

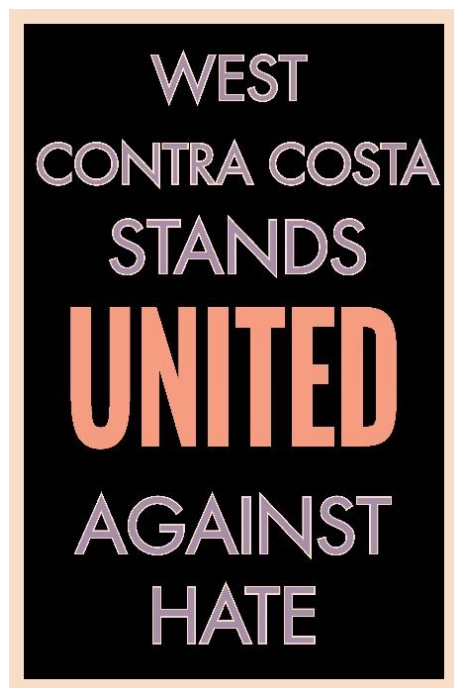
## **Celebrate Picture Book Month**

The subject was arrested, for the warrants, and was transported to the Martinez Detention Facility and her Audi was towed. **(H21-1506).**

The Moraga Officer also took possession of the stolen mail and most of the other items. An HPD Officer interviewed the female regarding possible stolen items found inside her wallet. The female was released pending further investigation. The male was transported to the Martinez Detention Facility. (Case H21-1521 & H21-1522)
