#### **Indoor Mask Mandate**



In alignment with the State, Contra Costa and 10 other Bay Area counties and the City of Berkeley have lifted universal mask requirements for vaccinated people in most indoor public settings beginning February 16, 2022. The move comes as cases and hospitalizations have begun to rapidly drop around the state and region.

Unvaccinated individuals over age 2 are required to wear masks in all indoor public settings. Businesses, venue operators and hosts may determine their own paths forward to protect staff and patrons and may choose to require all patrons to wear masks. Everyone still needs to wear a mask in some places, such as public transit and healthcare facilities.

Bay Area health officers continue to strongly recommend masks be used as an effective tool to prevent the spread of the virus especially when case rates are high, or when additional personal protection is needed.

The California Department of Public Health (CDPH) continues to require masking in K-12 school settings but has indicated adjustments to the state's policies will be shared in the coming weeks. For early education programs, such as preschool and childcare settings, CDPH continues to require

masking for children older than age two. Workplaces will continue to follow the COVID-19 prevention standards set by CalOSHA.

#### Franklin Canyon RV Resort Project

At its regular meeting on Tuesday, February 8, 2022, the City Council held a public hearing and voted 4–1 to approve the lot line adjustment, parcel map, and design review permit for the Franklin Canyon RV Resort project, a proposal to convert the existing Franklin Canyon Golf Course into a recreational vehicle campground with amenities, including a new 10,500-square-foot clubhouse, and approximately 70 acres of open space to be granted to the John Muir Land Trust. #### PUBLIC WORKS DEPARTMENT

#### **Maintenance & Operations**

Staff completed their regularly scheduled custodial and facility-related tasks in public parks, buildings, and sewer lift stations. They cleaned up numerous illegal dumping, repaired street lights, removed litter on roadways, and removed a fallen tree limb from the Refugio Valley Pathway. Work continued on the annual tree pruning contract, graffiti was removed throughout town, and annual permitting work began with the Air Quality Board for the emergency generators.

# **Engineering**

The design plans are under review for the Sycamore Crossing development project, including the EBMUD relocation of the waterline into San Pablo Avenue and hotel. The improvement plans reached 100% completion for the mile long segment of replacement sewer trunk main leading into the Pinole-Hercules Water Pollution Control Plant and the project will be bid out once permits are obtained from regulatory agencies. Design on the Regional Intermodal Transportation Center (RITC) is advancing utilizing \$1.2M in grant funding and the City has contracted with GBS to develop a funding plan to complete the project. Plan check is underway for private development projects including Franklin Canyon RV Park and the Willow Storage Facility. The Civic Drive/Sycamore Avenue Pedestrian Enhancement Project is nearing completion. Construction was completed on the Turquoise Avenue Rehabilitation Project and the final billing is being processed while design is nearing completion for the Sycamore Avenue Rehabilitation Project, which is scheduled for the Summer. The peer review process is underway for the Palm/Willow Sidewalk Project, a necessary step to receive a \$1M grant, and that project is tentatively scheduled for construction this Summer.
