Dear Village Parkway Neighborhood Resident,

The City of Hercules is developing a traffic calming plan for Village Parkway and Hercules Avenue. The goal of this plan is slow traffic down, increase safety, encourage more walking and bicycling, and create an environment that enhances the quality of life for street users and adjacent residents.

At last November's Public Safety & Traffic Council Subcommittee Meeting, residents in Village Parkway communicated traffic-related concerns and issues they were experiencing in the neighborhood to City staff. We have developed a traffic calming plan to address these concerns, which can now be viewed on the City's homepage at www.ci.hercules.ca.us. Scroll down to the News/Updates section and click on the article titled: Draft Traffic Calming Plan for the Village Parkway Neighborhood.

We are seeking your input on this traffic calming plan at the Wednesday, March 30 Public Safety & Traffic Council Subcommittee Meeting.

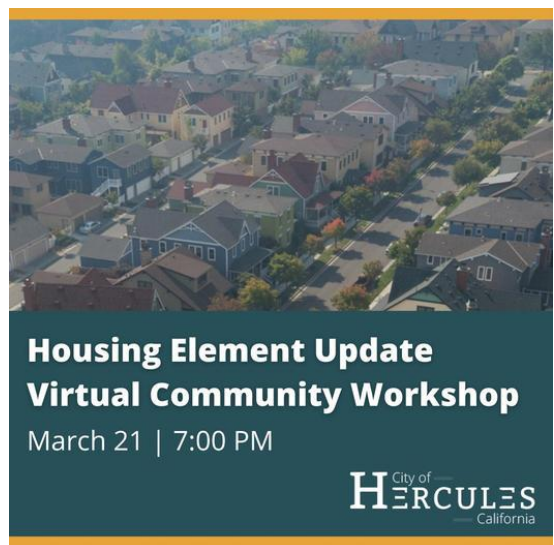

PUBLIC WORKS DEPARTMENT



Maintenance & Operations

Staff completed their regularly scheduled custodial and facility-related tasks in public parks, buildings, and sewer lift stations. They cleaned up numerous illegal dumping and graffiti throughout town. A contract is being processed for \$50K to repair tripping hazards at various locations. A contractor was secured for trimming trees around the Refugio Tennis Courts and the landscape screening around the Corporation Yard is being scheduled for installation.

Engineering

The design plans are under review for the Sycamore Crossing development project, including the EBMUD relocation of the waterline into San Pablo Avenue and hotel. City is waiting for permits from regulatory agencies so the Sycamore Trunk Sewer Replacement Project can be bid out. This project will replace a long segment of sewer trunk main leading into the Pinole-Hercules Water Pollution Control Plant. Design on the Regional Intermodal Transportation Center (RITC) is advancing utilizing \$1.2M in grant funding and the City has contracted with GBS to develop a funding plan to complete the project. The sewer conveyance system for the Willow Storage Facility Developer is under review. The Civic Drive/Sycamore Avenue Pedestrian Enhancement Project and Turquoise Avenue Rehabilitation Project has been substantially completed and will be coming before the City Council for acceptance March 22. The Sycamore Avenue Rehabilitation Project was cleared by Caltrans to advance to advance to construction using the \$392K in grant funding. A design contract amendment for the Palm/Willow Sidewalk Project will also be coming before Council March 22 for consideration and staff is pushing hard for the project to be ready for construction this coming season.

Woodfield Baseball Field

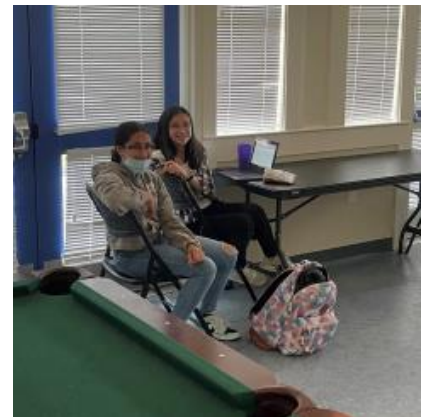

The "one person, one vote" doctrine requires electoral districts to be apportioned according to population - making each district roughly equal in population. To accomplish this, every ten years we redraw the district lines on our public offices using data gleaned from the Census. This effort is now being completed all over the U.S., and Contra Costa County is no exception. How were these efforts managed? Were citizens invited to participate in their own representation? What are Communities of Interest? Were Communities of Interest held together or diluted? What did agencies that "redistricted themselves" do to keep from giving preferential treatment to incumbents?

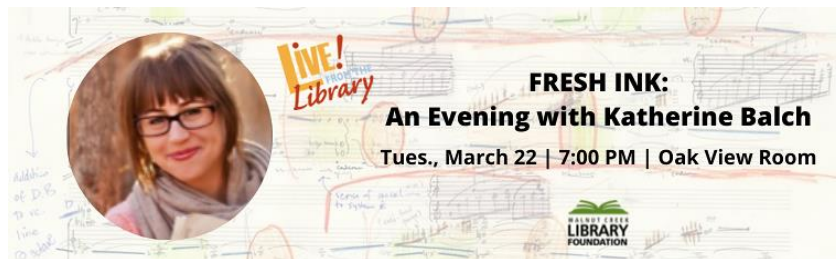

The California Symphony and Walnut Creek Library Foundation's Live from the Library series will host California Symphony's outgoing Young American Composer in Residence (YACR), Katherine Balch, for a conversation about the World Premiere of her work – Illuminate.
