Code Enforcement Division

Code Enforcement staff investigate and follow up on requests for enforcement of the Municipal Code on private property. Residents are encouraged to use the **Hercules Connect** app, available on the [Apple App Store](#) and [Google Play Store](#), to place requests for code enforcement. The app allows you to track a request and see when it has been acknowledged or closed.

As of August 3, a total of 63 requests have been closed, and 25 requests are open. The most common types of enforcement requests are requests for verification of permit status; inoperable vehicles on private property; junk & debris on private property; and recreational vehicle, boat & trailer storage.

Prior to filing a code enforcement request to inquire if a project has permits, interested members of the public should first verify the status of building permits by visiting the Contra Costa County Department of Community Development website’s [Permit Portal](#), clicking on “Inspection Schedules & Permit Status,” and entering the address, or by visiting [this direct link](#).

Code Enforcement staff visit the site of all requests and attempt to contact the property owner or occupant, leaving literature behind to explain the relevant code provisions. If an issue is not corrected promptly, a courtesy Warning Notice may be issued, followed by a formal Notice to Abate with a deadline for correction. If the deadline is not met, an Administrative Citation may be issued to the property owner. Repeated or unpaid citations will result in escalating fines that could be assessed against the property if not paid.

- Approved Administrative Design Review Permit #22-29, a request from Hercules Land Partners LP to construct a 561-foot retaining wall at the northeast property line behind Block M & P, 1100 & 1200 Bayfront Loop.
- Approved Administrative Design Review Permit #22-33, a request from Chito Valeros of Cadmate Design, representing Brandon Romero to construct a 450 square foot partially enclosed covered patio with sun deck above at 325 Grenadine Way.

PUBLIC WORKS DEPARTMENT

Maintenance & Operations

Staff completed their regularly scheduled custodial and facility-related tasks in public parks, buildings, and sewer lift stations. They cleaned up illegal dumping and also removed graffiti throughout town. Staff managed the Baywood Tree Removal and Replacement Project. They secured bids to remove 5 Palm trees at Leila By The Bay restaurant (property owned by the City) and approximately 40 pine trees in Victoria Linear Park. They also solicited bids to repair numerous sidewalks throughout town. Lastly, staff oversaw the quarterly maintenance of sewer lift stations and continued to build the new cabinets in Lupine Child Care. They also assisted with the clean-up of Refugio Park after National Night Out.

Engineering

The City finally received permits from regulatory agencies for the Sycamore Trunk Sewer Replacement Project and is now processing the UP Railroad permit. This project will replace a long segment of sewer trunk main leading into the Pinole-Hercules Water Pollution Control Plant. Design on the Regional Intermodal Transportation Center (RITC) is advancing utilizing \$1.2M in grant funding and the City has contracted with GBS who is developing a funding plan to complete the project. The sewer conveyance system for the Willow Storage Facility Developer is under review. Bids were opened for the Sycamore Avenue Rehabilitation Project and it is anticipated



Council will award the contract on August 9 with work starting in September. Staff is reviewing a surcharge grading permit for what known as the “Bowl” or Blocks ABCD located at the corner of Bayfront and Railroad. This area is part of the Bayfront Development and while the soil preparation is underway a project has not yet been approved for this site. Staff is finalizing a scope of work for the Parks Master Plan and is soliciting proposals for the Beechnut Park Improvement Project.

Aquatics

Aquatics Staff Training



At our weekly Aquatic Training we practiced the American Red Cross timed response test. The timed response test helps the guards recognize, rescue, and provide care in under 1:30 seconds. The lifeguards start by scanning to recognize the victim. Once the guard recognizes the victim, they activate the EAP (emergency action plan) by blowing their whistle to make sure all the guards know what to do. The guard does the appropriate entry, gets to the victim with the correct rescue. Brings the victim to the wall and extracts them using the backboard. After the victim is out of the water

the guards put on their PPE's and provide care on a manikin. Practicing and repetition helps the aquatic staff stay vigilant and rescue ready.

Aqua Zumba

Those looking to make a splash by adding a low-impact, high-energy aquatic exercise to their fitness routine while moving to amazing world music must join the fitness fun! Come join us at the Hercules Community Swim Center for Aqua Zumba on Wednesdays from 8:00-8:45pm and Sundays from 11:00am – 12:00pm.

Lap Swim

Summer lap swim times have changed. The mornings remain available from 9:15am to 12:45pm Monday through Thursday. However, the afternoons are no longer available for lap swim. On Saturday lap swimmers can swim from 1:00 to 4:00pm. And on Sunday from 11:00am to 12:00pm.

Recreation Swim

Recreation Swim is open all summer Mon-Sat, from 1:00 to 4:00pm through August 18. In addition, Rec Swim will be open on Saturdays from August 20-September 3, also from 1:00 to 4:00pm. Be sure to bring plenty of drinking water, sun protection, towel, and swimsuit.

Traditional Camps

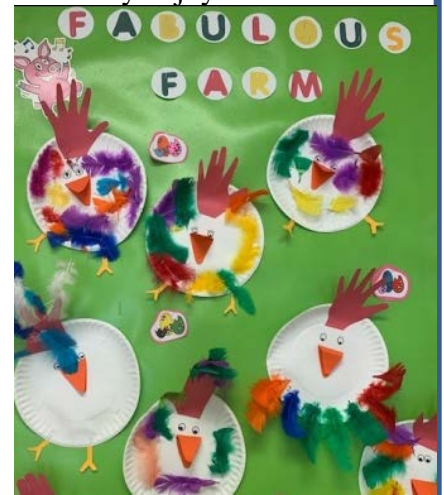

HICAP Counseling

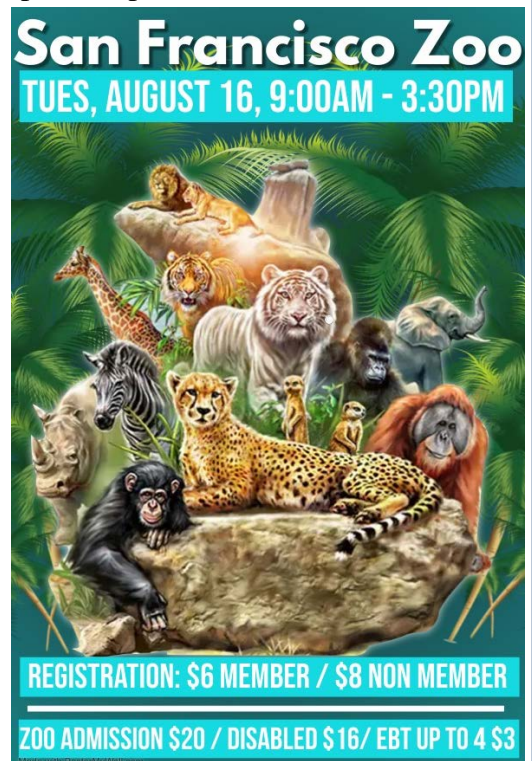

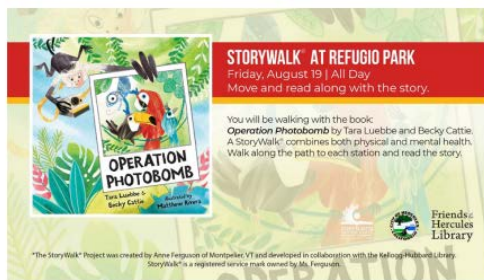

Therapy dogs provide a nurturing acceptance and a warm empathy that makes children feel safe, bringing a nonjudgmental space for learning.

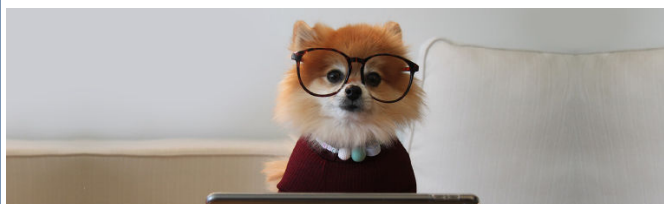

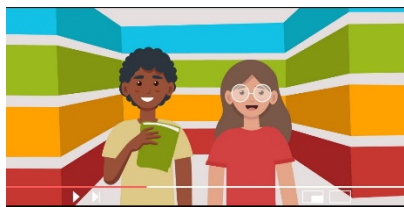
