THE COMMUNITY

The City of Hercules is ideally situated on the shores of San Pablo Bay in the northern San Francisco East Bay area. The city is named for the Hercules Powder Company, a major manufacturer of dynamite and other explosives from the late 1800's until 1974. Hercules has evolved from a "company town" to a diverse economy of technology, biomedical, and retail services in a suburban setting. The City of Hercules enhances its small-town ambience with several annual community events, like a Fourth of July parade, Halloween Carnival, and a Holiday Tree Lighting ceremony. Hercules has taken advantage of its location on San Pablo Bay by offering residents and visitors an extensive network of bayside biking and walking trails.


Major employers include Bio-Rad Laboratories, Home Depot, Lucky Supermarkets, Pacific Bio Labs and Benda Tool & Model Works. The Bayfront Chamber of Commerce which serves the city of Pinole as well as Hercules, actively supports local businesses by sponsoring local business promotion events, including supporting the city's the Yiftee Community Digital Gift Card Program. Interstate 80 runs from San Francisco through the middle of the City of Hercules and is the principal transportation link between Sacramento and the Bay Area. With a community of over 26,000 residents, the City of Hercules offers excellent business opportunities, as well as a vibrant lifestyle that combines outdoor activities with urban amenities. With an average household income of \$138,310, Hercules offers significant consumer spending opportunities.




LABOR MARKET BREAKDOWN

The occupations that are located within the City of Hercules:





SALES TAX SUMMARY


Hercules's total sales tax revenues grew 87% over the period between 2014 to 2021, especially in the Building & Construction segment as the sales tax revenue of the economic sector doubled in 2021 when compared to 2014. The growth is attributed to the Bayfront mix-use project in The Village area along with several new retail projects. Other than the Building & Construction segment, sales tax revenues for both Business & Industry as well as Food & Drugs segments have also experienced significant growth at 100% and 97% respectively.

The population in the city of Hercules has been growing steadily, industrial/commercial/ residential developments having influenced and created an increased demand for all business segments except General Consumer Goods. The Building & Construction, Business & Industry, Food & Drugs and Restaurants & Hotels segments all reflected higher-than-state-level growth during the comparison period between 2014-2021.


EMPLOYMENT SUMMARY

During the period between 2014 and 2021, the total labor force (including unemployment) expanded 1%, increasing the labor force with 3,900 positions. However, it is worth mentioning that the total labor force expanded 4%, adding 22,200 positions to Contra Costa County when comparing the labor force prior to the COVID -19 Pandemic between 2014-2019. Between 2014-2021, Service Providing industries added 9,400 positions while Good Producing industries added 2,500 positions.


The largest volume increase was Educational & Health Services, where 11,700 jobs were added representing a 19% increase. Other top growth categories were Mining, Logging & Construction (18%), and Professional & Business Services (6%) where each performed well above or in-line with statewide growth levels.

Furthermore, the unemployment rate for the City of Hercules was lower than the statewide level (7.3%) at 6.3% in 2021.



Year-over-Year Unemployment Rate






