Towed Vehicle: On April 4, 2023 at 10:31 a.m. An Officer checked on an unoccupied Gold '01 Acura MDX parked in the Home Depot parking lot. The MDX's registration expired in August 2021. An orange 2023-year tab was affixed to the rear license plate in violation of 4462.5 VC. The MDX was towed. **(Case H23-335)**

MSIN: On April 4, 2023 at 11:13 a.m. An Officer was dispatched to a lobby detail regarding a mandated reporter who wanted to report a 16-year-old female juvenile patient told her she was sexually assaulted. The Officer contacted the female juvenile and her mother for interviews. The female juvenile only told the Officer that a year ago, she and a friend were at her residence and ate Marijuana edibles. The female juvenile then stated her male friend, "forced himself on her." However, the female juvenile didn't want to go into further detail, nor did she identify the male friend. The mother declined to provide any further information. **(Case H23-336)**

Child Endangerment: On April 4, 2023 at 4:02 p.m. Officers were dispatched to Refugio Valley Park, 1515 Refugio Valley Rd. for a report of a man who kicked a baby near the playground. The suspect was described as a Hispanic male adult, wearing a white shirt and black pants. Officers located a 21 year old male, of Richmond, seated near the playground with his girlfriend and two small children. The male matched the suspect's description and was detained. Witnesses told Officers the female juvenile victim (V) and her mother had left the park. A witness told Officers that the suspect got upset at his child being knocked over and intentionally kneed V while yelling at her mother. An Officer contacted V's mother and she returned to the park. V (2 years old) was not injured and didn't have any visible injuries. The mother also corroborated the witness's statement that the suspect intentionally kneed her daughter after getting upset his daughter was accidentally knocked over. The mother signed a complainant's arrest form and the suspect was arrested for child endangerment. **(Case H23-337)**

Missing Person: On April 4, 2023 at 3:56 p.m. An Officer was dispatched to the 100 block of Thrush Court to take a missing person's report. The reporting party (RP), 71 year old male of Hercules, told the Officer he wanted to report his son (MP), 38 year old male of Hercules, missing. RP told the Officer he hadn't seen his son for two weeks and he was last seen at home. RP told the Officer his son was possibly driving his Gray '13 Infiniti M37 that's registered to him at the residence. A Flock search was done, and the last capture of his vehicle was on March 17, 2023 in Vallejo. The M37's rear license plate was captured attached to the rear of a Blue/Gray Honda Civic on April 2nd in Vacaville. The Officer later contacted Dispatch to attempt to ping Samuel's cell phone. **(Case H23-338)**

Death Investigation: On April 4, 2023 at 4:22 p.m. an Officer was dispatched to the 900 block of Bacchus Road for a non-breather. Dispatch advised a male was in cardiac arrest

and CPR instructions were being given. The Officer contacted the reporting party (RP), 56 year old male of Hercules. RP told the Officer he located his brother, 63 year old male of Hercules, deceased on the condo's balcony. The decedent had obvious signs of death (rigor mortis). The Officer didn't locate any evidence to indicate the death was a crime. The decedent didn't have any documented illnesses or medical conditions and hadn't been seen by a doctor in numerous years. The on-duty Contra Costa County Coroner's Deputy was contacted and agreed to take possession of the decedent's body. **(Case H23-339)**

<u>Warrant Arrest:</u> On April 4, 2023 at 10:24 p.m., an officer conducted a traffic enforcement stop on a black Audi near Safeway located at 4080 San Pablo Ave. A records check on the occupants revealed the front passenger, 20 year old male out of Santa Rosa, had a 5K non citable warrant from Pleasant Hill PD for battery. The suspect was taken into custody and booked at Martinez Detention Facility without incident. **(H23-340)**
