Under instruction of the subject, the victim purchased a large dollar amount of Bitcoin and transferred it to the subject so that the subject could safely hold her money. <u>Vehicle Vs. Bicyclist</u>: On April 10, 2023, at 12:30 PM, Officers were dispatched to a vehicle versus a bicyclist on Bayfront Blvd at Sanderling. Upon arrival, the bicyclist had a large gash in his right elbow and several other lacerations on his body. The driver was on scene with no injuries. The collision occurred when the bicyclist was traveling northbound on Bayfront Blvd and a 2012 Dodge Charger was turning east onto Sanderling from southbound Bayfront Blvd. The bicyclist struck the front end of the Charger and went into the windshield and then over the roof of the vehicle. Criminal Threats / Stalking: On April 10, 2023, at 7:01 PM, an officer responded to a lobby detail regarding threats and stalking. The victim stated she had an affair with the suspect, 43 year old male out of Vallejo, who was a subcontractor that did work on her house. When the victim recently called off her relationship with the suspect he immediately began stalking and threatening her via email. The victim further explained, she was sexually assaulted by the suspect a year ago in Vallejo. The victim provided pictures and emails to support her allegations. The officer contacted a judge who granted an Emergency Protective Order (EPO) for the victim. The officer was not able to contact the suspect but sent a photo of the EPO to his cell phone number and email address. The victim was advised to call immediately if she is alerted of the suspect's presence around her home. The officer provided a courtesy follow for her back to her home from HPD. The investigation is ongoing. **H23-00366.**
