**Suspended Driver's License for DUI:** On April 13, 2023, at 7:49 am, an officer conducted a traffic enforcement stop for a vehicle code violation at Willow Ave and Palm Ave. The driver, 27 year old male of Pinole, was found to be driving on a suspended license for DUI. The subject was cited and released. **H23-00371**

**Natural Death:** On April 13, 2023, at 3:40 pm, officers were dispatched to the 100 block of Civic Drive for a possible coroner's case. Officers arrived on scene and located a 74 year old female deceased in her apartment from apparent natural causes. The coroner released the body to the family. **H23-00372**

**Parole at Large/Resisting Arrest/Felon in poss. of a firearm:** On April 13, 2023, at approximately 6:46 pm, an officer conducted a pedestrian stop in the 800 block of Willow Ave for a municipal code violation. The subject, later identified as a 34 year old male of Oakland, initially gave officers a different name. When the officer attempted to use the fingerprint reader to ID him, the subject attempted to flee on foot, at which time the subject actively resisted officers attempting to detain him. In order to overcome the subject's resistance, he was tased. The subject was detained without further incident and AMR arrived to assess the subject for injuries. The subject had a Toyota car key in his pocket. Officers located a brown Toyota Sienna in front of Starbucks which the key belonged to. An ID search of the Sienna was conducted, and an unregistered pistol was located on the floorboard between the driver and passenger seat. Dispatch later advised the subject had an outstanding Parole warrant. The subject was transported to County Regional Medical Center where he was medically cleared prior to being booked at Martinez Detention Facility with a Parole hold granted by CDCR. The Sienna was towed. **H23-00374**

**Driving on Suspended License for DUI:** On April 14, 2023, at 7:36 am, an officer conducted a traffic enforcement stop on a 2013 Kia for a vehicle code violation. The driver, 26 year old male of Vallejo, was found to be driving on a suspended license for a DUI offense. The driver was cited and released. **H23-00375**

**Missing Person Run A Way Juvenile:** On April 14, 2023, at 7:55 am officers were dispatched to the 1300 block of Chelsea for a suicidal subject. The reporting party called to report her 16 year old son as being a danger himself. Officers arrived on scene to contact the subject and found that he had left the residence out his bedroom window. An area check was done for the subject, and he was not located. A Be on the Lookout (BOLO) was sent out to local agencies, and he was entered into MUPS. **H23-00376**

**Supplement:** On April 14, 2023, at 9:20 am, an officer located a subject with an outstanding Ramey warrant in the 2000 block of Bayfront Blvd. The subject, 21 year old male, was arrested and transported to Hercules PD for an interview. **H23-00356**

**Warrant Arrest:** On April 14, 2023, at 1:28 pm, a subject came to the lobby who had an outstanding warrant and wanted to turn himself in. The 60 year old male out of Rodeo, had an outstanding cite releasable warrant out of Napa County. The subject was cited and released on his signed promise to appear. **H23-00377**

**DUI:** On April 14, 2023, at 8:35 pm an officer conducted a traffic enforcement stop at Safeway Gas Station, 4000 San Pablo Avenue. The vehicle was a black Nissan Murano, and the driver was identified as a 38 year old female of San Pablo. The subject displayed signs of intoxication and performed poorly on Standard Field Sobriety Tests. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. She was arrested and transported to Pinole PD for a breath test. **H23-00379**

**Mental Health:** On April 15, 2023, at 4:56 am officers responded to the 100 block of Paradise Drive where the reporting party's 29 year old son was having a mental episode throwing items in his room. The subject met the criteria for a 72 hour evaluation and was transported to the County Regional Medical Center without incident. **H23-00380**

**Stolen Vehicle:** On April 15, 2023, at 8:00 am, an officer was dispatched to the Police Department for a stolen vehicle report. **Theft by False Pretenses:** On April 15, 2023, at 12:08 pm, an officer was dispatched to the Police Department Lobby for a Fraud report. The victim, 51 year old male, reported he was led to believe he was investing in Crypto Currency and was tricked into putting a large amount of money into this account before he realized he was being taken advantage of. **H23-00384**

The RO had reported his vehicle stolen after he believed it had been stolen, but he later found his vehicle and did not want to wait for Alameda Police to recover the vehicle. The driver, 30 year old male of Vallejo, and passenger, 26 year old female of Vallejo, were released per 849PC and at the request of the owner were given back the vehicle after it was located in SVS. **H23-00385**

**Poss. of controlled substance/Warrants:** On April 16, 2023, at approximately 1:50 am, an officer checked on a suspicious vehicle at Jack in the Box. The driver, 38 year old female of Oroville, CA, was determined to have two outstanding citable misdemeanor warrants out of

Butte County (**H23-00387**). A search incident to arrest of the subject resulted in suspected Fentanyl tucked in her bra. The subject was cited and released on the warrants and possession of a controlled substance. **H23-00388**

**MSIN:** An officer was flagged down in the area of Forest Run for a welfare check request on a residence in the 1200 block of Forest Run. The Reporting Party stated she had not seen the resident for multiple weeks. The officer located an open rear door at the home and conducted a protective sweep of the residence. **Warrant Arrest:** An Officer conducted a suspicious vehicle check on a 2019 Kia Optima while parked at the gas pumps at Shell gas Station. A passenger in the vehicle, 26 year old female of Stockton, was found to have an outstanding no cite warrant for her arrest held by Walnut Creek PD.
