**Obstructing/Delaying/Resisting a Peace Officer:** On April 12, 2023, at 8:35 AM, an Officer checked on an unoccupied Cadillac XTS with expired registration in 2020. The Officer elected to tow the vehicle and was waiting for a tow truck when the vehicle's owner approached them. The subject, 55 year old male of Orinda, became uncooperative and did not listen to the Officer. The subject then walked past the Officer, entered the vehicle and was reaching to start the vehicle. The subject was asked multiple times to comply and exit the vehicle. The subject refused; he was removed from the vehicle by the Officer's and detained. The subject was found to have a valid moving permit issued by the DMV, but it was not properly displayed. The tow was cancelled, and the subject was cite released on scene for violating 148(a) PC. **H23-00369**

**Poss. of a stolen vehicle/Poss. of stolen property/Poss. of burglary tools/Poss. of drug paraphernalia/False ID to Peace Officers/Identity theft/Poss. of a controlled substance:**

On April 12, 2023, at 9:53 AM, Officers received a Flock camera notification of a White Volvo SC70 traveling southbound Willow Ave at Sycamore Ave with a stolen rear license plate attached to it. Officers located the vehicle parked at Home Depot and observed a male subject standing near the vehicle. Once Officers got to the vehicle the male was gone from the area. A record check of the vehicle VIN revealed the 2015 Volvo SC70 was reported stolen to Piedmont PD in January 2023. A detective located a male matching the subject seen near the Volvo. The 44 year old male was detained and subsequently placed under arrest. The subject had a fraudulent CA Driver's License with someone else's name and information, but his photograph. The subject began to suffer a seizure and was unresponsive but breathing. Fire and EMS responded and transported him to Richmond Kaiser. An Officer went to Richmond Kaiser to utilize a fingerprint scanner to properly identify him. A search of the Volvo yielded suspected Methamphetamine, drug paraphernalia and a very large quantity of Mail from various cities throughout the Bay Area. The Mail was given to the proper postal inspector to investigate. A blank check and another CA-Driver's License of someone else was located as well. **H23-00370**
