Lost Property/Unauthorized use of an access card: On April 17, 2023, at 10:06 a.m. An Officer was dispatched to a lobby detail to take a report for a wallet that was lost or stolen. The victim, 66 year old female of San Pablo, told the Officers she lost her wallet at Kinder's, 3600 San Pablo Ave., this past Saturday, April 15th, between 12:30 p.m. to 1:30 p.m. The lost wallet contained credit/debit cards and cash. The victim received fraud alerts from several of her credit/debit cards. The victim told the Officer her cards had been used at multiple stores. The investigation is ongoing. **H23-00392**

Mental Health Evaluation: On April 17, 2023, at 7:40 p.m. officers were dispatched to a call of a 61 year old female, residing in Sapphire Court, calling in to report her parents and kid were being held inside a house in the first court off of Obsidian Way. An officer attempted contact with the reporting party (RP) via telephone but was unsuccessful. At 9:28 p.m., the RP called again to state she saw a female hanging from her patio and screaming. Officers contacted the RP in Sapphire Ct. where she was unable to intelligently articulate what she allegedly observed, and was advised to talk with a doctor, but she declined. The RP was further advised to get some rest and stay inside for the rest of the evening. At 10:10 p.m., a resident in the 100 block of Spinel Ct. called in to report a female was wandering around in the court and not familiar to the area. Officers responded and located the 61 year old female caller from earlier on Obsidian near Spinel Ct. Due to her delusions and repeated behavior, the subject was determined to be gravely disabled and detained for a 72-hour mental health evaluation. AMR responded and took custody of the subject without incident. **H23-00393**

Domestic Battery: On April 18, 2023, at 1:51 a.m., officers were dispatched to the 100 block of Sunflower Ct. for a report of the Reporting Party's ex-girlfriend, 21 year old female, refusing to leave the 25 year old male's, reporting party/victim (RP/V), residence. RP/V stated the subject was intoxicated and hitting him. Upon arrival, the subject was hysterically crying and claimed RP/V choked her, but she did not have any visible injuries. After further investigation including video evidence and statements, it was determined the subject showed up at RP/V's residence uninvited after drinking all day and sending him irate text messages. RP/V, who was not home at the time, responded to his residence after the subject stated she was there. When RP/V arrived, the subject began hitting on him and when he called the police, she slapped his cell phone out of his hand. RP/V stated he put the subject in a head lock to restrain her because she was out of control. Medics responded to the scene to assess the subject for injury and stated she needed to be transported due to her level of intoxication and claims of losing consciousness. The subject was determined to be the aggressor and was placed under arrest. Officers responded to Kaiser Richmond where she was cleared medically. The subject was transported back to HPD for further interview and served with an Emergency Protective Order. After the interview, the subject was booked at Martinez Detention Facility without incident. **H23-00394.**
