Registration: On April 20, 2023, at 11:10 am, a 72 year old male came into the station for his annual registration. **H23-00399**

Stolen Vehicle Recovery: On April 20, 2023, officers received a Flock notification of a stolen red Toyota Corolla out of Richmond. An officer located the vehicle on April 21st at 12:46 am parked unoccupied in the 100 block of Grenadine Way. While approaching the vehicle, the officer located a 37 year old female from Kentfield. The subject admitted to driving the vehicle and taking it from a gas station in Richmond. Officers were able to confirm she was driving the vehicle and determined she was the only occupant. The subject was arrested and transported to Martinez Detention Facility without incident. **H23-00400**

Warrant Arrest: On April 21, 2023, at 10:05 am, an officer conducted a traffic enforcement stop at San Pablo Ave. and Linus Pauling Dr. on a 2007 Pontiac G6 with no plates. The driver was identified as 27 year old male out of Washington and had two non-citable warrants. The subject was transported to Martinez Detention Facility without incident. **H23-00401**

Use of Another's Name to Purchase a Vehicle: On April 21, 2023, at 10:27 am, a resident from the 500 block of Black Walnut called to report someone had used his name to purchase a Ford Raptor Truck at a dealership in New Hampshire. The officer contacted the Dealership who advised the transaction was completed over the phone and they had no information on the suspect. The dealership stated there was no middle name listed on the Driver's License that was used to purchase the vehicle however the victim does have his middle name listed on his Driver's License. The officer advised the dealership the vehicle was purchased fraudulently and that they should report it as stolen to their local police department. **H23-00402**

Miscellaneous Information: On April 21, 2023, at 1:12 pm, a 40 year old female from North Carolina, came to the police department to report a child custody order violation. The female stated that her ex-husband violated the court order by signing their 16-year-old son up for school at Hercules High School without her agreement, violating the court order. The female had a court appearance on 4/18/2023 in which the judge heard the case. The female still demanded a report be taken to document the unfounded violation. **H23-00403**

False Report of An Emergency: On April 22, 2023, at approximately 11:39 am, Hercules officers received a call from an individual who resides in the 400 block of Sparrow Drive. The individual claimed he is a schizophrenic and would harm his sister if officers came to his house. Dispatch provided several phone numbers for the caller and several family members. Contact was made with the family in the 400 block of Sparrow over the phone. A resident advised the real caller lives in Berkeley and does not have a sister. Officers responded to the scene and requested the family step outside the home to ensure their safety. The residence

was searched by officers and the incident was confirmed to be unfounded. The reporting party (RP), 26 year old male, later called and advised he was receiving text messages from an unknown person demanding the RP give up access to his online gaming profile. The RP believes this unknown person is attempting to intimidate him into giving up his profile. The number was investigated and was found to not be registered to anyone. **H23-00405**

Found Property: On April 22, 2023, at 5:24 pm an officer was flagged down regarding a wallet which had been found at the 76 Gas Station. The officer attempted to reach the owner by phone but was unsuccessful. The wallet was stored for safekeeping. **H23-00406**

Possession of Controlled Substance: On April 22, 2023, at 9:12 pm an officer checked on a suspicious blue Toyota with Oregon plates parked at the 76 Gas Station, 828 Willow Avenue. The officer contacted a 43 year old male from Sacramento. The officer noticed drug paraphernalia in plain view and a search was conducted of the subject and his vehicle. During the search the officer located suspected fentanyl and heroin. The subject was arrested, then cited and released on scene. **H23-00407**

Warrant Arrest: On April 23, 2023, at 12:50 am an officer conducted a traffic enforcement stop at Refugio Valley Road and Partridge Drive on a black BMW. The driver was identified as a 29 year old male, of Hercules, who was on Parole, and the passenger was identified as a 31 year old female of Richmond. The female had an active no bail warrant out of Contra Costa. The female was arrested and transported to Martinez Detention Facility. **H23-00408**

Driving Under the Influence: On April 23, 2023, at 1:49 am an officer conducted a traffic enforcement stop at Jack in the Box at 3800 San Pablo Avenue. The vehicle was a tan Toyota Camry, and the driver was identified as 35 year old male from Hercules. The subject displayed signs of intoxication and was given the Standard Field Sobriety Tests. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. The subject was subsequently arrested for driving under the influence and transported to HPD for a blood draw. The subject was later cited and released to his wife. **H23-00409**

Possession of a Loaded Unregistered Firearm/Towed Vehicle/DNA Search Warrant: On April 23, 2023, at 9:04 am an Officer did a traffic stop on a White '16 Honda Civic on Parker Ave at 7th St. for expired registration (October 2022). The driver was identified as a 20 year old male, of Rodeo. While talking to the subject, the Officer observed suspected loose Marijuana, suspected Marijuana inside a sandwich baggie, and smelled a strong odor of burnt Marijuana. The subject admitted to smoking Marijuana yesterday inside the vehicle. A probable cause search was done. During the search, the Officer located an unregistered pistol underneath the driver's seat. The Officer also found a plastic bag on the rear passenger seat that contained 60 loose rounds of ammo. A ski mask, Halloween style mask, and a window punch device were also found inside the vehicle. The subject was arrested and interviewed on scene. He declined to provide any information. The vehicle was towed. The subject was transported to HPD where an on-call Detective responded to write a DNA search warrant to collect a sample of his DNA. The subject was then transported to Martinez Detention Facility. **H23-00410**

Mental Health Evaluation: On April 23, 2023, at 10:31 am Officers were dispatched to the 100 block of Sparrow Drive for a report of a female attempting to harm herself. Dispatch advised the female was inside the garage with a hose hooked up to her car. Officers were already familiar with the 59 year old female subject (SUB) of Hercules. Officers located the SUB inside the residence, and she initially refused to comply with our verbal commands. However, the SUB was convinced to exit the residence and was secured on an AMR gurney.

Officers saw a garden hose taped to the exhaust pipe of a vehicle parked inside the garage. The reporting party (RP) was contacted and told Officers that the SUB told him she wanted to harm herself after he gave her an eviction notice. The RP then found SUB seated inside her vehicle with the ignition running and the garage door closed. The SUB exited the vehicle and went inside the residence after being found by the RP. The SUB was determined to be a danger to herself and was transported to County Regional Medical Center by AMR for a psychiatric evaluation. **H23-00411**

Warrant Arrest: On April 23, 2023, at 1:36 pm Officers went to the 100 block of Robin Court to serve an outstanding cite releasable Misdemeanor Warrant on a 19 year old male of Hercules. The Warrant was issued on 04/20/23. The subject was cited and released. **H23-00412**

Driving Under the Influence: On April 23, 2023, at 9:29 pm, officers received a request for a welfare check on an unknown female who parked in the Reporting Party's (RP) driveway located in the 100 block of Topaz Court. The RP described the woman, identified as, 41 year old female, as a female adult, 25-30 years old, wearing a black hoodie and being "out of it". While in route, the subject drove away from the residence but returned within minutes where she parked in the RP's driveway and exited the vehicle. Officers contacted the subject out of her vehicle in the area and her silver Honda was parked crooked in the driveway of a home in the 100 block of Topaz Court. The subject displayed symptoms of being under the influence of drugs and/or alcohol and admitted to drinking earlier in the day. The subject refused to take sobriety tests and was placed under arrest. The subject consented to a breath test and was transported to HPD for a blood test. The subject refused the blood test, and the officer subsequently obtained a blood draw warrant. During the blood draw, the subject became resistive and had to be restrained. After the blood draw, the subject calmed down and was cite released to her sister upon her signed promise to appear. The Honda was towed. **H23-00413**
