Suspended Driver's License (Driving Under the Influence): On May 1, 2023, at approximately 8:17 AM, an Officer conducted a traffic stop on a GMC, on San Pablo Ave at Tsushima St. for a traffic violation. The 53 year old male driver, of San Pablo, was found to have a suspended license for prior DUI's. The subject was cite released on scene for the violation. **Case 23-00444**

Warrant Arrest: On May 1, 2023, at approximately 10:11 AM, an Officer conducted a pedestrian stop on, a 31 year old female, in front of a business, in the 800 block of Willow Ave. The subject had an outstanding warrant from our agency. The subject was arrested and transported to the Martinez Detention Facility. **Case 23-00447**

Shoplifting/Warrant Arrest X2/ Bringing Controlled Sub. Inside Jail: On May 1, 2023, at approximately 10:44 AM, Officers were called to Rite Aid for a theft that had just occurred. The reporting party (RP) advised an adult female, in a red jacket, left, the store with unpaid merchandise. The suspect got into the passenger seat of a Nissan Kick. The vehicle left towards Sycamore Ave. Officers located the Nissan entering onto westbound I-80 from John Muir Parkway. The 30 year old female passenger matched the description given by the RP. The subject was detained, and an in-field show up was conducted. The witness made a positive identification. The subject was found to have two outstanding, no bail, warrants issued by Solano County. The subject was cite released for shoplifting and transported to the Martinez Detention Facility on her outstanding warrants. While at the jail, an intake deputy located suspected Methamphetamine inside of one of the subject's body cavities. The subject was booked on an additional felony charge. **Case 23-00445**

Injury Traffic Collision: On May 1, 2023, at approximately 11:34 AM, Officers were dispatched to San Pablo Ave at John Muir Parkway for a report of a collision. Officers arrived and determined the 31 year old female driver, of a Silver Mustang, was traveling northbound on San Pablo Ave. The Mustang collided with the rear end of a Red Toyota Rav4, driven by a 58 year old female. The driver of the Mustang was medically evaluated at the scene, for pain from their legs and forearm, and released. **Case 23-00446**

Battery on a School Employee/ Possession of Marijuana on School Grounds: On May 1, 2023, at approximately 1:41 PM, Officers were dispatched to the High School. A 16 year old male, student reportedly pushed his way into the principal's office and was refusing to leave. Officers contacted the student with the principal and a school security officer. The Officer determined School Security found the Juvenile, in the bathroom, smoking a marijuana vape pen. School security confiscated vape pen and detained the Juvenile, then escorted the Juvenile to the Principal's office. While there, the Juvenile pushed the Principal's door open and went into the office. The Juvenile confronted the Principal demanding his property back. The Juvenile pushed the school security officer multiple times. The security officer desired prosecution for the battery. The possession of a restricted substance, on school property, is

being handled by the school. The Juvenile was cited and released to his father. **Case 23-00448**

Criminal Threats: On May 1, 2023, at approximately 3:25 PM, Officers were dispatched to Taco Bell for a report of a subject brandishing a firearm at an employee who was in their vehicle on break. Officers contacted the 19 year old male victim who stated he was in his vehicle on break, when the suspect pulled his vehicle in front of his. The suspect confronted the victim about following him around town. The victim had never met the suspect or seen him before. The suspect then stated to the victim he would have to use his protection the next time he saw the victim and motioned as if he had a firearm on him. The victim believed he had a firearm and was in sustained fear for his life and safety. The victim desired prosecution. **H23-00449**

72 Hour Mental Health Evaluation Hold: On May 01,2023, at 7:04pm, the Fire Department requested Officers to respond, with them, to the 200 block of Sparrow Dr. for a reported 46-year-old male who was trying to hurt himself. Officers contacted the subject who displayed systems of alcohol intoxication. The subject was determined to be a danger to himself. and was transported to the County Regional Medical Center **H23-00451**

Hit and Run (Misdemeanor): On May 1, 2023, at 7:49pm, an Officer was flagged down in the 1900 blocks of Pheasant Dr. for the report of a hit and run. The adult victim stated that an unknown suspect, driving a white pick-up truck. collided into his 2009 Chevy Sliverado. The victim's vehicle was parked along the curb across the street from his home. The collision caused damage to the Silverado's rear bumper and left taillight. The suspect fled the scene without leaving a note or exchanging information. **H23-00452**

Attempt Extortion: On May 1, 2023, at 9:08pm, an Officer handled a lobby detail regarding attempted extortion. The adult male victim stated that he recently began speaking to a "female friend" via Snapchat. During their contact the victim reportedly exchanged photos of himself with his Snapchat friend. The "friend" took a screen shot of the photos and threatened to share them with all of victim's Instagram followers if he didn't pay her. The victim did not pay the money she requested. **H23-00454**
