**Robbery, Child Endangerment, Contributing to the Delinquency of a Minor:** On May 3, 2023 at 9:14am, Officers were dispatched to a 911 disconnect near Burger King, in the 800 block of Willow Ave... The responding officer arrived on scene after the suspect had already fled. The officer contacted the 49 year old female reporting party, and victim. The victim is an employee at Burger King. The victim stated the 24 year old female suspect got upset over the price of her order and began to scream at employees. The victim refused service to the irate suspect. The suspect had her 9 year old son jump the counter and steal the food. The employees attempted to recover the food, at which time the suspect also jumped over the counter and began to steal food. The suspect shoved the victim and forcefully pushed the door into her, to escape with the stolen food. **H23-00456**

**Destruction of Firearms:** On May 3, 2023 at 11:24am, Officers were dispatched to a residence on Mandalay Avenue to collect two firearms for destruction. The reporting party said the firearms belonged to his stepfather who had recently passed away. **H23-00457**

**Battery on a Police Officer, Failure To Yield:** On May 3, 2023 at 3:12pm, an officer conducted a traffic stop on a gray Nissan Versa; with a temporary plate; for vehicle code violations. The vehicle yielded and the officer contacted the 29 year old female. The subject was immediately combative and agitated. The officer asked the subject for identification. The subject forcefully threw her driver's license at the officer's face striking the officer in the neck. The subject then fled the scene in her vehicle. Officers did not pursue the vehicle as they were able to identify the suspect since she left her ID behind. The officers began to circulate the area. An officer located the vehicle parked, and occupied by the subject, on Cayman at Grenadine. The subject was detained without incident. The subject was arrested and transported to the Martinez Detention Facility. The Nissan was towed from the scene. **H23-000458**

**Service of No Trespassing Documentation:** On May 3, 2023 at 5:38pm, Officers were dispatched to a call of two adult female subjects. The subjects have reportedly committed several thefts from Rite Aid, and were refusing to leave the store. Officers contacted the two subjects. They were advised Rite Aid no longer wanted them to enter the store. They further advised they would be arrested if they returned to Rite aid. Both subjects signed Hercules PD trespass forms and were released. **Incident 23-05030145**

**Vehicle Collision:** On May 3, 2023, at 9:10pm, Officers were dispatched to the area of the 2000 block of Refugio Valley Rd., for the report of a vehicle crash involving a black Toyota Supra. Dispatch was notified of the collision by the involved vehicle's onboard collision reporting system. Officers located the black 2022 Toyota Supra, at the base of a large Eucalyptus tree, located at the northwest corner of Refugio Valley Rd and Redwood Rd. The Supra had major front-end damage and the vehicle's safety airbags were deployed. Both the 18 year old male driver, and the 18 year old male passenger, were located standing outside

the Supra with apparent injury. Both parties declined medical assistance. Upon further investigation the driver reportedly lost control of the Supra while entering the roundabout (located at Refugio Valley Rd and Redwood Rd/Falcon Way) from westbound Refugio Valley Rd. The Supra came to rest after it drove over the curb and collided head on into the tree. Officer determined the vehicle belonged to a friend of the driver. According to the driver, he and the friend temporarily swapped cars. The Supra's owner was contacted by phone and responded to the scene. The driver and passenger were picked up by the driver's father. The owner of the Supra arranged for his vehicle to be towed. **H23-00459**
