<u>Warrant Arrest:</u> On May 5, 2023 at 1548 hours, a 24 year old female, Hercules resident, came to the Hercules PD lobby for a vehicle release. A records check was conducted which determined the subject had a citable warrant, out of Napa County. The subject was placed under arrest, cited, and released along with her vehicle. <u>H23-00460</u>

**Solo Vehicle Collision:** On May 6, 2023 at 8:08am a 65 year old female was driving her 2001 white Buick Century North on San Pablo Avenue, at Sycamore avenue: The driver advised her brakes became inoperable as she approached the intersection of San Pablo Avenue and Sycamore. In order to avoid colliding with other vehicles, the driver quickly turned to go West on Sycamore Avenue from San Pablo Avenue. The driver lost control of her vehicle and struck the North curb line of Sycamore Avenue, two street signs, and a tree. <u>Attempted Occupied Stolen Vehicle Recovery:</u> On May 6, 2023 at 12:49pm, FLOCK notified officers of a stolen Hyundai Tucson driving West on Sycamore Avenue near the clock tower. An officer observed the stolen Hyundai driving North on San Pablo Avenue and began to trail it. The Hyundai immediately took off at a high rate of speed merging onto I-80 West from John Muir Parkway. The driver of the stolen Hyundai was a male approximately 18-25 years old with short, dark hair. A pursuit was not initiated. CHP was advised of the information. <u>Incident Number 23-05060105</u>

The subject was found by his father with blood on his face.
