Felony Evading/Hit and Run Collision : On May 8, 2023, at approximately 8:36 AM, an Officer observed a Mercedes 4-door leaving the Home Depot parking lot area. A traffic stop was attempted, for multiple Vehicle Code violations, in the 1500 block of Sycomore Ave. When the officer activated the overhead lights and siren the Mercedes accelerated aggressively, drove through two vehicles, colliding with one in the process. The Mercedes jumped the sidewalk curb and drove through the mud and grass near the clock tower to evade capture. The Mercedes was not pursued and the Officer terminated due to the recklessness of the driver. The Mercedes was last seen entering on I-80. The driver was observed to be an adult female with a pony tail and glasses. It was later learned the female attempted to purchase over \$1,000 dollars worth of merchandise at Home Depot. The cashier declined the sale, as the cash appeared to be fake money. The victim vehicle, involved in the hit and run collision (Honda Element), stopped at Shell Gas Station. An ambulance responded to evaluate a 1 year old child, in the backseat of the vehicle, for precautionary reasons. It is believed the child may have sustained whiplash, but was cleared on scene. The Mother stated she will take her child to her primary care provider for evaluation and notify us if there is confirmed injury. **Case 23-00469/23-00470**

Miscellaneous Investigation: On May 8, 2023, at approximately 5:05 PM, an Officer was flagged down. The reporting party said they had seen a passenger in a vehicle with a rifle on his lap. The citizen provided a license plate. A FLOCK search was conducted and the vehicle was identified as a Black Ford Fusion, and was seen driving up Lupine, at Heather. A short time later the vehicle was located in the 400 block of Falcon Way. A traffic stop was conducted. Three adult males, and one juvenile male, were detained. The 21 year old driver, and registered owner, had a an address in Hercules. There were two airsoft rifles and an airsoft handgun located inside of the vehicle. A case was taken for documentation. The property was released back to the driver, and the occupants were released. **Case 23-00471**

Possession of Controlled Substance: On May 9, 2023 at 1:41am, an officer checked on a vehicle, with temporary plates, in the park in ride across from 828 Willow Ave. Upon contact, the officer noticed drug paraphernalia in the vehicle's center console. A search of the occupants, and vehicle, was conducted. The 31 year old female front passenger, of Grass Valley, was placed under arrest for possession of suspected methamphetamine, and suspected fentanyl. The subject was cite released. **H23-472**.

Warrant Arrest: On May 9, 2023 at 5:03am, an officer conducted a traffic stop on a vehicle near the Home Depot located at 1625 Sycamore Ave. A Records check on the 41 year old male driver, of Modesto, revealed he had a \$200,000 warrant for his arrest, for Vehicle Theft, out of Modesto PD.
