Found Property: On May 11, 2023, at 11:14 am, an officer located a Chevrolet truck parked in the Creekside Shopping Center. The truck had plates on it, which were reported lost or stolen, and the vin did not match. The owner of the truck was contacted, and it was determined that his plates were stolen and later located on a stolen vehicle. The plates, currently on the truck, were stolen. The plates were taken and booked into evidence as found property. **H23-00486**

Miscellaneous Information: On May 11, 2023 at 12:22 am, officers were dispatched to an outside assist, for Richmond PD, in the area of San Pablo Ave at John Muir Parkway. An owner was following his vehicle, which had just been stolen in Richmond. Officers located the suspected stolen vehicle, a black 2002 Chevrolet Tahoe near 1500 Sycamore Ave. A stop was conducted on the Tahoe. A 19 year old male, of Vallejo, was detained without incident. It was determined the stopped vehicle was not the suspected stolen Tahoe. Richmond PD responded to take the stolen vehicle report. Located Occupied Stolen Vehicle, Possession of Burglary tools, and Drugs: On May 12, 2023, at 8:38 am officers were notified, via Flock, of a Stolen 2003 Ford Explorer traveling southbound San Pablo Ave. at Victoria Crescent. An officer located the vehicle, parked in front of Chase Bank, with a 42 year old female, of Stockton, sitting in the driver seat. Driving Under the Influence: On May 12, 2023, at 6:27 pm, officers were advised of a White Honda Civic coming into town from Pinole on San Pablo Ave. The caller stated the driver of the Honda was drinking out of a wine bottle. An officer located the vehicle on San Pablo Ave, and a traffic stop was made. The 49 year old female driver, was contacted. A strong odor of an alcoholic beverage was coming from the subject, and inside the vehicle. Officers also saw a wine bottle behind the passenger side seat. The subject was given the Standard Field Sobriety test. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. The subject was arrested, and she was later cited and released to a family member. The Civic was parked. **H23-00495**

Driving Under the Influence: On May 13, 2023 at 1:03 AM an officer conducted a traffic stop in the 1000 block of Civic Drive on a black Toyota Camry. The 68 year old male driver displayed signs of intoxication. The subject was given the Standard Field Sobriety test. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. The subject was arrested, and later cited and released to a family member. **H23-00496**

Non-Injury Collision involving City Vehicle: On May 13, 2023, at 6:04 pm a city employee, driving a city Ford Ranger, hit a parked vehicle causing minor damage. The victim vehicle was a Honda Accord. The owner was notified. **H23-00497**

Mental Health Evaluation: On May 14, 2023, at approximately 10:44 AM, Officers were dispatched to the 100 block of Beryl Ct . The reporting parties stated their 15 year old son was physically harming his 10 year old sister. Officers arrived on scene and determined the 15 year old had physically harmed his sister. The subject was determined to be a danger to others. The subject was taken to the County Regional Medical Center to be evaluated. **Case-23-00499**

Driving Under Influence: On May 14, 2023, at 11:49 pm, an officer checked on a vehicle stopped in the turn lane from southbound San Pablo Ave to eastbound Sycamore Ave, with the driver passed out. The 44 year old male driver, of Hercules, was woken up and instructed to pull out of the roadway. The subject began driving southbound in the northbound lane on San Pablo Ave and had to be directed, over the PA system, to pull into 3600 San Pablo Ave. The subject displayed symptoms of intoxication. The subject was given the Standard Field Sobriety test. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving.
