Stolen Vehicle: On May 17, 2023, at 8:48 am, an Officer was dispatched to the 200 block of Beechnut Dr. for a stolen vehicle report. The victim stated that sometime between yesterday at 1 pm and today at 8:45 am, an unknown suspect stole his Black 2019 Dodge Charger. The vehicle was entered into SVS. **H23-00513**

Found Property Turned in for Destruction: On May 17, 2023, at 12:39 pm, an officer was dispatched to a lobby detail for a resident wishing to turn in ammunition for destruction. The resident was cleaning out his deceased grandfather's belongings and found some old ammo he wanted to discard. **H23-00514**

Shoplifting: On May 17, 2023, at 3:11 pm, two females fled from Big Lots after stealing pots and pans. The females left in a white Dodge Caravan. The investigation is ongoing. **H23-00515**

Warrant Arrest: On May 17, 2023, at 5:35 pm, an officer knew there were two females that were wanted out of San Francisco and believed that she had seen one in a group of subjects on Tuscany Court. The officer was able to detain one female from the group. The 33 year old female was found to have an outstanding non-cite releasable warrant out of Contra Costa County. The subject was transported to Martinez Detention Facility. One of the other subjects who fled was determined to be a 37 year old female who is wanted out of San Francisco. **H23-00516**

Methamphetamine/Fentanyl for Sales/Warrant Arrest: On May 17, 2023 at 11:47 pm, an officer conducted a traffic enforcement stop on a no plate blue Jeep Liberty. The officer observed drug paraphernalia in plain view. The driver, 21 year old male of Sacramento, and passengers, 30 year old male subject (SUB 1) and 34 year old female subject (SUB 2) of Sacramento, were detained without incident. A search of the vehicle was conducted and suspected Fentanyl and suspected Methamphetamine were discovered. A scale as well as several baggies, commonly used to sell illegal narcotics, were discovered. SUB 1 was determined to have 3 outstanding warrants out of Placer County and 1 outstanding warrant out of Sacramento County. SUB 1 was transported to Martinez Detention Facility and booked on his warrants as well as Methamphetamine and Fentanyl for sales. SUB 2 was also transported to Martinez Detention Facility and charged with Methamphetamine and Fentanyl for sales. The driver was released at the scene. **H23-00517**
