<u>Mental Health Evaluation:</u> On May 18, 2023, at 3:04 pm, officers were dispatched to the Hercules Middle School for a juvenile who was reportedly having suicidal thoughts. The student was found to be a danger to himself and was transported to the County Regional Medical Center, by AMR. <u>H23-00519</u>

<u>Outside Assist Robbery in Progress:</u>: On May 21, 2023, at 6:14pm, Pinole PD requested assistance from outside agencies to assist with a reported robbery in progress at Safeway (1421 Tara Hills Dr.). Hercules PD, Contra Costa SO, and San Pablo PD K9 responded and assisted with a perimeter lockdown and clearing of the store. At the conclusion of the search, no suspects were located inside the store. **Incident #2305210165**

Warrant Arrest/Possession of a Controlled Substance: On May 21, 2023, at 7:46pm, Officers were dispatched to eastbound I80 near Willow Ave for the report of a female running on the freeway. While enroute, Dispatch advised an adult female hopped over the center median and was running across the freeway. Upon arrival to the area, Officers located a a 28 year old female. of Stockton, who matched the subject's description, on the Willow Ave offramp from eastbound I80. A Records check revealed the subject had three outstanding misdemeanor warrants. One warrant was out of Solano County; and the other two warrants were out of Amador County. Domestic Violence/Burglary/Vandalism/Damaging a Communication Device with Intent to Prevent Help: On May 22, 2023, at 12:12am, Officers responded to The Grand Apartments for the report of banging and screaming that could be heard above the reporting party's apartment. Upon arrival, it was determined that the banging and screaming originated from an apartment on the third level. The adult female victim told dispatch her 36 year old boyfriend kicked in her front door and broke her phone. The victim was contacted at another apartment. She stated the suspect came to her apartment and appeared to have been drinking. The suspect kicked in the front door to the victim's apartment and proceeded to physically attack her. The suspect damaged the victim's iPad. The suspect also took the victim's cell phone, credit cards, and ID from her wallet. The suspect then fled the scene. Immediately after the suspect left the victim ran to another apartment and called 911 to report the incident. Officers conducted a security sweep of the victim's apartment to ensure the

suspect was not inside. He was not located inside the apartment, nor was he located on the apartment complex's premises. AMR arrived on scene and examined victim for her injuries. and she declined any further medical assistance. An Emergency Protective Order was granted.
