Fraud: On May 23, 2023, at approximately 1:06 pm, the victim (V) arrived at the Police Department lobby to report fraud. V was alerted by a collections agency that a T-Mobile account had been opened under her name and her social security number. The T-Mobile account had a balance of \$3,620 dollars that was sent to collections. V did not open the account and has no idea who did. There are no suspect leads. **H23-00538**

Grand Theft: On May 23, 2023, at 7:30 pm, an Officer was dispatched to Safeway, 4080 San Pablo Ave, for a reported theft of bicycles. The two 16 year old victims rode their bicycles to Safeway at approximately 7:00 pm. They parked their bikes, unsecured, in the designated bike area in front of the store and then went inside the store. Approximately 5 minutes later, they returned to their bikes and noticed the bikes were gone. The two boys contacted their moms, who both responded to Safeway to pick them up. Their mothers then contacted HPD to report the theft. The combined estimated value of the bicycles is \$1,300.00. The investigation is ongoing. **H23-00539**

Residential Burglary: On May 23, 2023, at 7:55 pm, an Officer was dispatched to the 2000 block of Clark St. for the report of a residential burglary that occurred earlier in the day. The Reporting Party (RP), 34 year old female, stated an unknown suspect entered her garage at approximately 5:55 pm and stole her 30 year old brother's (V-Victim) \$1,300.00 BMC bicycle. At the time the theft occurred, the RP stated the garage door was left open so that her kids could come and go as they played outside. Surveillance video from neighboring homes captured video of the incident and officers were able to get a description of the suspect and his clothing. The suspect in the video is described as an adult male, approximately 25 years old. The suspect left behind a mountain bike on the RP's driveway, which was processed for DNA and collected as evidence. On May 24, 2023, at approximately 12:36 am, HPD Officers were in the area of California St. in Rodeo on a call. An Officer spotted a male suspect riding a bicycle along the sidewalk, while hand towing a BMC bicycle that matched V's bike. The suspect was detained without incident and was identified as a 29 year old male transient out of Rodeo. The suspect was wearing the exact same clothes as the suspect captured in the above-mentioned surveillance video. Upon further investigation, it was determined that the BMC bicycle in the suspect's possession was the one stolen from the RP's garage. The BMC bicycle was collected and brought back to HPD. The RP and V later responded to HPD, and V confirmed it was his bike. The BMC bicycle was returned to V, and the suspect was transported to Martinez Detention Facility. **H23-00540**
