<u>Mental Health Evaluation</u>: On May 25th, 2023 at 8 :58am, officers were dispatched to the Glenwood Complex for a disturbance. The reporting party advised her 13 year old daughter had been acting erratic and aggressive. The juvenile was breaking items around the house. The mother attemtpted to stop juvenile and she assaulted her mother. The mother was uninjured. The juvennile was determined to be a danger to others, and was transported to the County Regional Medical Center for Evaluation. <u>H23-00544</u>

False ID to Peace Officer: On May 26, 2023, at 12:51 pm, an officer conducted a traffic stop on a 1996 Dodge Van for a vehicle code violation. The subjects in the vehicle were recognized as theft suspects from Big Lots last week. The 39 year old female passenger, of Oakland, gave a false name to the officer and was arrested. She was cited and released on her signed promise to appear. <u>H23-00545</u>.

<u>Outside Assist</u>: On May 26, 2023, at 5:07 pm, officers responded to cover Contra Costa County Sheriff's Office on a Felony Car stop at 4th and Parker Ave, in Rodeo. The vehicle had four subjects in the vehicle that were wanted in connection with a home invasion robbery. Two suspects had fled from the vehicle. Five suspects were ultimately arrested. The Sherriff's Department is handling the case and arrest. A HPD case was taken for documentation of the outside assist. <u>H23-00546</u>

<u>Mental Health</u> On May 25, 2023 at 10:54 PM officers responded to the 700 block of Turquoise Drive where a 13 year old female had called the suicide hotline saying she attempted to hurt herself. Upon arrival officers contacted the foster parents and the juvenile. The juvenile was determined to be a danger to herself and was transported to the County Regional Medical Center, by AMR. **H23-00547**

Coroners Case: On May 27, 2023, at 08:09 am, officers were dispatched to the 1000 if Earnest St. for a male who was possibility passed out and not breathing. Officers arrived on scene and located a 76 year old male who showed objective indicators of being deceased. The subject was reportedly previously diagnosed with a serious medical condition. The subject's body was released to the family by the coroner. **H23-00548**

<u>**Transport:**</u> On May 27, 2023, at 11:00 am, an officer responded to the Solano County Jail to pick up 61 year old male on a Hercules warrant. The subject was transported and booked at the Martinez Detention Facility without incident. <u>H23-00549</u>

<u>Warrant Arrest:</u> On May 27, 2023, at 10:12 pm, Officers were dispatched to the BART, lot on Willow Ave, to assist with a subject who refused to exit a bus. Officers contacted a 61 year old male transient, out of San Francisco. Officers were able to get the subject to exit the bus without incident. A Records check revealed the subject had an active cite-releasable warrant out of Contra Costa County. The subject was arrested and issued a new court date, He was then released from custody on his signed promise to appear. <u>H23-00550</u>

Home Invasion: On May 28, 2023, at 6:25 AM, Officers were dispatched to the 100 block of Finch Ct for a report of a subject breaking into the victim's house. The vicitm advised a male had broken his rear glass door and entered into the residence. The victim fled the residence, out of the front door, and ran to his neighbor's home and called the police. The victim was able to access surveillance video, at the residence. The video showed an African Amcerican male, wearing a blue jacket, black sweatpants and a shirt wrapped around his face, inside the residence. Both Hercules Police Nightshift and Dayshift Officers responded and set a perimeter around the house, with the assistance of CCSO and Pinole PD. Richmond Police K9 and his Handler responded to the scene. An entry team was formed and entry was made to clear the residence. No suspects were located inside of the residence. Further investigation indicated the suspect attempted to pry open a window with no sucess. The suspect then picked up a brick and threw it thorugh the sliding glass door. The victim yelled at the suspect, then the vicitm fled out the front door. The victim advised cash and a watch were stolen. A neighborhood canvas was completed. At approximately 9:48 AM, a neighbor in the 100 block of Bluebird Ct (previously spoken to during the neighborhood canvas), advised he was flying his personal drone and located the possible suspect hiding in the green belt area near some rocks. While Officers were in route, the citizen updated the officers that the subject had left the hiding place. The subject got into a Gray sedan, that appeared to be driven by an Uber driver. Officers located a Gray Honda Accord, with Uber insignias in the window, at the corner of Meadowlark and Tanager Way. A high-risk stop was conducted and a subject, matching the exact description of the suspect in the surveillance video, exited the rear passenger seat of the Honda. A search of the rear passenger seat of the Uber revealed the missing cash and the watch, on the floorboard where the 17 year old male suspect, of Texas, was seated. The suspect was taken into custody. The suspect was transported and booked at the Juvenile Detention Center for various charges. Case 23-00551

Domestic Violence: On May 28, 2023 at 7:15pm, officers responded to the Aventine Apartments (1375 Sycamore) for a report of Domestic Battery. The 45 year old male victim stated he was involved in an argument with his 31 year old wife when she turned violent and began punching him in the chest and face. The victim left the apartment in order to avoid further conflict and notified the police. The victim did not have any visible injuries and refused medical attention. Officers contacted the suspect. She was deemed the dominant aggressor. The female was arrested and booked at the Martinez Detention Facility. The victim declined an EPO **H23-00552.**
