Miscellaneous Information/ Narcan Administration: On June 8, 2023, at 1:36 pm, Officers were dispatched to the Bart Transit Lot at 1375 Willow Ave. for a subject who had overdosed sitting on a bench. Officers arrived on scene and located a 31 year old male transient not breathing and unresponsive. Officers administered two doses of Narcan and got back respirations on the subject. He was transported to the County Regional Medical Center for further medical treatment. **H23-00592**

Court Order Violation: On June 8, 2023, at 4:49 pm, an officer was dispatched to the 2200 block of Redwood Road for a restraining order violation. The victim stated the 30 year old male, of Vallejo, texted her in violation of a served court order. **H23-00593**

Towed Vehicle: On June 8, 2023, at 6:05 pm, an officer responded to John Muir Parkway and San Pablo Ave. for a vehicle parked in the grass just off the roadway. Officers had gotten complaints all day on the vehicle and gave the owner until 6:00 pm to get the vehicle moved. The owner, 49 year old male transient, did not move the vehicle. The registration on the Black 1999 Lexus expired in 2015 and was towed. **H23-00594**

Violation of Court Order: On June 9, 2023, at 8:18 am, officers were dispatched to the Hercules Library at 109 Civic Dr. The Reporting Party (RP) stated a 35 year old male was in front of the main doors in violation of a court order. The RP provided a current, valid restraining order stating the subject could not be within 100 feet of any Library in Contra Costa County. The subject was arrested and transported to Martinez Detention Facility, and his dog was picked up by Contra Costa County Animal Services. **H23-00595**

Battery: On June 9, 2023, at 1:06 pm, officers were dispatched to the intersection of Sycamore Ave and San Pablo Ave. for a vehicle accident. While enroute officers were advised that the parties were engaged in a physical altercation and one party was trying to take the other parties' purse. Officers arrived on scene and found a very minor collision and that party one (P1), 29 year old female of San Francisco, tried to take the purse of the other party in an attempt to get her to not leave the scene. In the attempt to take her purse, an independent witness said they saw P1 punch party two (P2), 60 year old female of San Pablo, at least twice in the face. P2 wished to press charges and P1 was cited and released on her signed promise to appear. An info exchange was done for the collision. **H23-00596**

Suspended Driver's License for Driving Under the Influence: On June 9, 2023, at 3:52 pm, an officer conducted a traffic enforcement stop on a Silver 2001 Audi in front of Subway. The driver, 52 year old male of El Sobrante, was found to have a suspended Driver's License for Driving Under the Influence. The subject was cited and released on his signed promise to appear. The vehicle was driven by a licensed driver. **H23-00597**

Warrant Arrest: On June 6, 2023, at 10:26 pm, an officer checked on a suspicious black Mercedes in front of Burger King (836 Willow Ave). The driver and sole occupant, 28 year old female of Oakland, had an outstanding citable felony warrant out of Sunnyvale PD. The subject was cited and released, with a new court date, on scene. **H23-00598**

Occupied Stolen Vehicle: On June 11, 2023, at approximately 6:00 pm, Officers received a Flock notification for an outstanding stolen 2012 Kia Sorrento traveling on Sycamore at Palm Ave. An Officer located the vehicle traveling on Willow Ave and followed from a distance. The Kia entered the Willow shopping center and parked on the side of Mazatlan. Two occupants exited the vehicle and were subsequently detained. Suspect one, 34 year old male, and suspect two, 35 year old female of Concord, were identified as the occupants. Suspect two was released on scene as she was the passenger of the vehicle. Suspect one was the driver of the Kia and found to be on Contra Costa County probation. Suspect one was transported to Martinez Detention Facility without incident. The Kia was released to the victim/owner after they responded to the scene. **H23-00600**

Domestic Violence: On June 11, 2023, at 11:59 pm, officers responded to the 400 block of Lighthouse Court for a Confidential Victim (CV) requesting information about obtaining an Emergency Protective Order (EPO) after kicking her 38 year old boyfriend out of the residence. Officers learned the subject assaulted (CV) by poking her in the face several times while yelling at her. While on scene, the subject walked out of the surrounding vegetation and was subsequently arrested without incident. An EPO was granted and served to the subject prior to being booked at Martinez Detention Facility. **H23-00601**

Auto Burglary / Attempted Vehicle Theft: On June 12, 2023, at 3:39 am, officers responded to the area of Bluebird and Meadowlark for a report of subjects looking into parked vehicles with a flashlight. No vehicles in the area were broken into and the subjects were not located. At 4:25 am, officers were called back to the area for two subjects in the street with flashlights near the intersection of Sparrow and Bobolink. An area check revealed three vehicles in the area with broken windows, but no items taken and one of the vehicles had ignition damage from an attempted vehicle theft. No subjects were located. At 5:57 am, officers responded back to the area for what appeared to be the same subjects attempting to steal a vehicle in the 2100 block of Pheasant Dr. which was previously broken into during the previous call. Upon contacting the Reporting Party (RP), officers were shown video of what appeared to be two juvenile males. One subject was inside the RP's vehicle and the second subject was standing outside. The subjects fled the area when the car's alarm sounded and ran into Thrush Ct. A third juvenile male met up with the other two as they ran into Thrush Ct. Officers canvassed Thrush Ct. on foot and talked to several residents but did not locate the subjects or any information about them. The investigation is ongoing. **H23-00602**
