Injury Collision: On June 15, 2023, officers responded to the 100 block of Caprice Circle for a subject who drove their motorcycle through the garage. The subject (SUB) was identified as a 35 year old female from Hercules. She was the only one involved in the collision when she lost control of her 2023 Kawasaki motorcycle and collided with the garage door. SUB sustained minor injuries to her right leg and was cleared by AMR, and later would self-transport to a hospital if needed. **H23-00613**

Felony Domestic Violence/ Child Endangerment: On June 16, 2023, at 3:32 am officers responded to the 400 block of Seagull Court where the victim (V) advised her 33 year old boyfriend, from Hercules, had beat her up. Officers attempted to have the subjects step out of the residence but initially both refused. As officers were going to make entry the male subject (SUB) stepped out and was detained. Officers cleared the residence and located SUB's 10-year-old son in his room. V was then located in the garage. V had moderate to major injuries to her face and bruising throughout her body. SUB's son was picked up by a family member. An Emergency Protective Order was granted, and SUB was arrested and transported to HPD prior to being taken to Martinez Detention Facility. V was transported to a hospital for her injuries. Child Protective Services was also contacted for notification. **H23-00614**

Auto Burglary: On June 16, 2023, at 1:04 pm a resident from the 2200 block of Redwood Road called to report that her vehicle had been broken into sometime on June 3, between 2pm and 7pm. An unknown suspect stole the victim's wallet which contained her driver's license, and her social security card. The suspect also stole her bottom dentures which were in the glove compartment. **H23-00615**

Non-Injury Collision: On June 16, 2023, at 2:30 pm, a case was taken for a patrol car that collided into a parked vehicle at a very slow speed while making a U-turn on Waverly Cir. No injuries, very minor damage to the citizens' vehicle and no damage to the push bumper of the patrol vehicle. **H23-00616**

Felon in Possession of Tear Gas: On June 16, 2023, at 4:08 pm, an officer conducted a consensual contact on a pedestrian stop. The officer contacted the 23 year old male subject (SUB), of Rodeo, who was found to be on Parole. The Officer conducted a parole search of SUB and found tear gas on his person. SUB was arrested and placed in the rear of a patrol vehicle. SUB was transported to Martinez Detention Facility. Parole was contacted and a parole hold was placed on SUB. **H23-00617**

Warrant Arrest: On June 16, 2023, at 6:23 pm, officers were dispatched to Home Depot for a possible theft in progress. Officers contacted a 28 year old male, of Richmond. The subject (SUB) was loading up a garbage can of items from behind locked cages in the store. SUB was found to be on probation and had an outstanding warrant. SUB was cited and released

on his signed promise to appear, and Home Depot asked him not to return to the business.

Shoplifting, Personate Another, Misappropriate Lost Property; Warrants: On June 17, 2023, at 9:25 am, officers were dispatched to Home Depot at 1625 Sycamore for a theft that had just occurred. Dispatch advised the suspect was a male in all black clothing and he left in a newer model Red Honda Accord with tinted windows. The take was two 5-gallon buckets of Primer. An officer located the vehicle at Sycamore and San Pablo Ave. A traffic stop was conducted, and the driver was identified as a 47 year old female of Vallejo. The officer was able to see the two 5-gallon buckets of primer in the back seat of the Honda. The passenger identified himself as a 27 year old male of Vallejo. The male subject lied about his name and officers determined him to be a 29 year old male, of Vallejo, who was on probation and had three outstanding warrants. The male subject also had another person's ID and debit card in his possession. The male subject was transported to Martinez Detention Facility without incident. **H23-00619**

Mental Health Evaluation: On June 17, 2023, at 9:36 am officers were dispatched to the 100 block of Oxford St. for a subject who was being aggressive towards his family. Officers arrived on scene and contacted the 34 year old male subject (SUB). SUB has a history of mental illness and had not taken his medication for a few days. SUB also admitted to using suspected Methamphetamine and the combination was making him aggressive and he had pushed over his mother. SUB was determined to be a danger to others and was transported to the County Regional Medical Center. **H23-00620**

Residential Burglary/Possession of Controlled Substances for Sales/Warrant Arrest X3 : On June 18, 2023, at approximately 10:39 am, Officers were dispatched to a suspicious circumstances, at a residence in the 100 block of Pepperwood Street, regarding two people who went into the back of a residence after parking their motorcycle in the driveway. Officers located a yellow Suzuki motorcycle parked in the driveway near the sideyard entrance. As Officers approached the residence, a 60 year old male subject (SUB 1), of Antioch, was walking from the sideyard to the motorcycle carrying a small box and Ziploc bags. SUB 1 was detained. Officers then walked the sideyard and into the backyard. The rear sliding glass door appeared shattered and announcements were made. A 37 year old female subject (SUB 2), of Hercules, exited the residence and was detained. The residence was cleared by Officers and no other outstanding subjects were located. SUB 1 was found to be on CDC Parole and Contra Costa County Probation. SUB 1 initially gave a false name but was properly identified and had 3 outstanding warrants from Contra Costa County for a Parole violation and Probation Violations. Officers spoke with the Reporting Party who stated he did not recognize them and he observed them park, exit the bike, enter the backyard and then enter into the house from the rear. A search of SUB 1 produced suspected Methamphetamine, small dime bags, and a sum of cash. A search of SUB 2 revealed suspected drug paraphernalia and suspected Methamphetamine. The resident of the home was located. SUB 1 and SUB 2 were placed under arrest for their various charges and transported to Martinez Detention Facility.

Vandalism: On June 19, 2023, at 5:49 am, an officer took a report for a vandalism that occurred at Jack in the Box located at 3700 San Pablo Avenue. The unknown suspect spray painted profanities on a utility box near the drive through entrance at an unknown date and time within the last week. Based on officer's prior knowledge of the graffiti style, the suspect is thought to possibly be a local 49 year old male transient. **H23-00622.**

Occupied Stolen Vehicle: On June 19, 2023, at approximately 12:53 pm, Officers received a Flock notification for a stolen 1995 Blue Toyota Tacoma, reported stolen out of Oakland PD

on 06-05-2023. Officers responded to the area and located the Tacoma parked, unoccupied near Bank of America. A male walking in the area was contacted and determined to be the driver of the Tacoma. The 44 year old male, of Oakland, was found to be the Registered Owner (RO) of the Tacoma. The RO stated he found his Tacoma parked in Oakland earlier in the day and took possession of it. The Tacoma was released on scene to the RO and taken out of SVS. **H23-00623**

Battery: On June 19, 2023, at approximately 3:05 pm, Officers were dispatched to a fight in progress in front of Lucky. Officers contacted a 15 year old male subject, of Hercules, and a 33 year old male subject, of Hercules. It was determined that SUB 2 got into an altercation with SUB 1 in the front of the store. SUB 2 believed SUB 1, who at the time was taking items from his pockets and handing them to his friend, was getting ready to attack him. SUB 1 believed SUB 2 was going to attack him after being allegedly shoved. Both parties physically fought and sustained minor injuries. Per the subjects' statements and witness statements it was unclear who the primary aggressor was. A case was taken to be forwarded to the District Attorney's office. **H23-00624**

Vandalism: On June 19, 2023, at 8:25 pm, an officer responded to the 100 block of Terrace Ct. for suspicious activity. The Reporting Party/Victim (RV), 57 year old male, stated at approximately 8:20 pm, he heard a loud bang at his front door. When RV went to check his door, he noticed the frame was damaged and witnessed 4-5 juveniles running from the area. RV did not know for sure if the juveniles or anyone else was responsible for the damage. The investigation is ongoing. **H23-00625.**
