<u>Lost Property:</u> On June 20, 2023, at approximately 8:24 AM, an Officer responded to the 100 block of Bonaire Ave for a report of a lost driver's license. The reporting party, 81 year old male, stated he had lost his driver's license sometime between June 17, 2023, and June 19, 2023. **H23-00626**

<u>Fraud:</u> On June 20, 2023, at approximately 10:46 AM, the victim (V), 51 year old female of Chicago, called regarding a fraudulent transaction that occurred in Hercules. V stated that two subjects entered Chase Bank and accessed her account using her information. The subjects then drained a large amount of money from her account into separate accounts. **H23-00627**

Occupied Stolen Vehicle: On June 20, 2023, at approximately 4:59 PM, Officers received a Flock notification for a stolen 2006 Lexus IS250, reported out of Concord PD, on Willow Ave at Cambridge. An Officer located the Lexus on Viewpoint at Coral Dr. The Lexus briefly drove on Coral Dr, observed the Hercules Patrol vehicle behind him and hit a sharp U-turn. An adult male with a bald head and black shirt was observed in the driver seat as he passed right beside the patrol vehicle. The driver then accelerated at a high rate of speed. The Officer did not activate his patrol lights and did not pursue the Lexus. The Officer trailed far behind as the Lexus continued up Viewpoint. The Officer lost sight of the Lexus on Viewpoint. In the area of Viewpoint at Seascape Circle, the Officer observed the same Lexus, crashed into the hillside with the driver door open. Multiple residents witnessed the subject run from the Lexus and begin jumping fences into residences backyards. As a perimeter was being set up, a resident observed the subject walking further down on Seascape Circle. An Officer in the area was able to challenge him and he was detained by other Officers. The 40 year old male subject, out of Pittsburg, was found to be on PRCS out of Contra Costa County. The primary Officer and a witness positively identified the subject. He was subsequently booked at Martinez Detention Facility. H23-00628

Domestic Violence Court Order Violation: On June 20, 2023, at 8:18 PM, officers responded to the 400 block Seagull Ct. for a Civil Standby requested by the victim (V). V, who has an Emergency Protective Order against the 33 year old male subject (SUB), stated she was heading to the residence to retrieve her vehicle and wanted officers to be present in case he was there. V stated she suspected SUB was inside the residence because their dog was there, and his vehicle was in the parking lot. V attempted to gain access to the residence with officers, but the electronic lock would not open. V provided officers with a key for the residence. Several call outs were made but there was no answer at the door. Officers noticed a light previously on inside the residence was now off. Officers attempted to gain entry with the key, but it no longer worked in the lock. V granted officers permission to force entry for a protective sweep. Entry was made and SUB was not located during both a preliminary and secondary search, but the dog was located inside. Officers re-secured the front door, conducted area checks and stood by while V retrieved belongings. Prior to leaving the

residence, V reluctantly informed officers that SUB was communicating with her via text, and she learned he was still at the residence hiding under the sofa on the balcony. Officers searched the balcony again and located SUB laying down inside the hollow cavity of the basket weave style outdoor sofa. SUB was taken into custody and booked at Martinez Detention Facility without further incident. **H23-00629.**
