Warrant Arrest: On June 22, 2023 an officer conducted a traffic stop on a Mazda, on San Pablo Avenue and John Street. The 31 year old female driver, from Richmond, had an active citable warrant out of Placerville. The subject was arrested, cited, and released on scene. **H23-00635**

Towed Vehicle: On June 22, 2023 officers received a FLOCK notification of a stolen Texas plate. The plate was registered to a Dodge. Officers noticed the plate was on a black Honda Accord and located the vehicle in the 100 block of Sequoia Road. After checking the VIN of the Honda, it was found to have expired registration since 2021. Officers attempted contact at the residence the vehicle was parked in front of, with negative results. The Honda was towed for expired registration and the Texas license plate was recovered. **H23-00636**

Suspicious Circumstance: On June 23, 2023 at 9:03 AM, Officers were Dispatched to the 1000 block of Lantern Bay for a suspicious circumstance. The reporting party stated on June 22, 2023 at 8:43 PM, two unidentified males, wearing ski masks, and hoodies, were recorded, via surveillance cameras, approaching the 1100 block of Lantern Bay. The males knocked on the door, then forcefully kicked the front door (the door was not damaged. The home owner yelled at the males, and they ran to a parked white Nissan Altima and fled the scene. An officer examined the scene. The surveillance footage was collected. **Incident Number: 23-0074**

Battery: On June 23, 2023 at 11:40 AM, officers were dispatched to the Home Depot parking lot for a report of a man who had been assaulted. Officers contacted the 44 year old male victim. The victim had bruising, and minor lacerations, to his face. The victim advised an unknown suspect punched him in the face and fled the scene in a black Toyota Avalon. Officers were able to obtain a vehicle description; possible license plate; suspect description; and surveillance footage of the incident. Follow up was conducted to positively identify a 35 year old male suspect. The victim was evaluated and cleared by AMR on scene. After the suspect was identified, and contacted by officers, the victim advised he no longer desired prosecution. The suspect was admonished and the case was completed. **H23-00637.**

Mental Evaluation: On June 23, 2023 at approximately 11:10 PM, officers were dispatched to the parking of Hercules Police Department for a subject stating people were following him. Officers determined the 66 year old male, of Richmond, was unable to care for himself. The subject was transported by AMR to County Regional Medical Center for evaluation. **H23-00638**

NON-Injury Collision: On June 24, 2023 at approximately 3:00 AM, officers were dispatched to the 300 block of Sparrow Dr. for vehicle that just hit a parked car. Officers discovered a white 2022 Toyota Corolla had collided with 2019 Lexus, which was parked on the curb in front of a residence. The 35 year old female driver, of the Corolla, lives in Mountain View.

She was evaluated by AMR, due to an air bag deployment, but received no injuries. The driver stated she fell asleep while driving. There was no indication of intoxication or impairment. **H23-00639**

Warrant Arrest: On June 24th, 2023 at 9 :46 AM, an officer contacted a 38 year old female, who was seated in a silver Honda Accord, parked in front of Home Depot. The officer detained the subject after observing drug paraphernalia in plain view. A second 39 year old male subject approached the scene stating the female was his girlfriend. The male was also detained without incident, after he advised officers he may have drugs on him. The male was searched and no contraband was located. A records check determined The female had an outstanding citeable warrant, for drug charges, out of Napa County. The female was arrested, cited, and released. The male was also released on scene. **H23-00640**

Theft of a License Plate : On June 24, 2023 at 12 :33 PM, an officer was dispatched to the 1300 block of Sycamore Avenue for a report of a stolen license plate belonging to a white Volkswagen Jetta. The reporting party had no suspect information and was unsure when the plate was stolen. The plate was entered into the Stolen Vehicle System. **H23-00641**

Warrant Arrest : On June 24th, 2023 at 5 :20 PM a driver was observed driving evasively. The officer conducted a records check on the license plate of the Honda Civic. The registered owner was determined to be a 43 year old male, and had a warrant out of San Bernardino County. The Officer initiated an investigative stop to verify the identity of the driver. The driver was positively identified as the registered owner of the vehicle. The subject was placed under arrest, cited, and released on his promise to appear. **H23-00642**

Towed Vehicle: On June 25, 2023, at approximately 8:33 AM, an Officer checked on a suspicious 2000 Mustang parked on Tioga Loop at Shasta Ln. The registration for the Ford was found to be expired in 2021 and had a 2023 registration tab affixed to the rear license plate. The vehicle was towed pursuant to the registration violation. **Case 23-00643**

Driving Under the Influence: On June 25, 2023, at approximately 6 :33 PM, Officers were dispatched to the intersection of Sycamore Ave at San Pablo Ave for a male asleep behind the wheel of his vehicle. Officers arrived and located a 35 year old male, of Pinole, asleep behind the wheel. There was a ¾ empty 750ml bottle of liquor his passenger seat of his vehicle. The subject was awakened and given the Standard Field Sobriety Test, but refused to do the Preliminary Alcohol Screening Test. The subject was subsequently placed under arrest for driving under the influence and having prior DUI convictions within the past 10 years. The subject was cited and released to a responsible party. **Case 23-00644**

Warrant Arrest: On June 26, 2023, at 12:54 am, an officer checked on an occupied white Chrysler minivan, parked at Refugio Valley Park. The van was broken down and the sleeping occupants; a 37 year old female out of Richmond, and a 45 year old male, out of San Pablo were woken up. A Records check revealed the male had an outstanding no bail warrant for his arrest out of San Mateo County. The subject was wheelchair bound. San Mateo County was re-contacted, and advised they would allow a cite release and provided the officer with a new court date. The subject was arrested, cited, and released upon his signed promise to appear. The subjects were allowed to make arrangements to have someone come help them with their vehicle in the morning. **H23-00645.**
