<u>Outside Assist:</u> On June 27, 2023, at 4:21 am, officers were dispatched to a request for assistance from Vallejo PD regarding a vehicle, they pursued into Hercules. The vehicle was wanted in connection with a commercial burglary committed in Vallejo. The suspect vehicle drove off the road, near the roundabout, on Refugio Valley Rd and was disabled. The single occupant fled on foot but was not apprehended by Vallejo Officers. Upon arrival, Hercules units assisted with coordinating resources, setting perimeter, and searching. A Richmond PD K9 unit responded to the scene but was not able to locate the suspect. Officers remained in the area until relieved by dayshift, but the suspect was still not located. Vallejo PD investigators responded to the scene to conduct further investigation and towed the vehicle. Hercules dayshift officers later took a collision report for some damaged piping near the roundabout. **H23-00653.**

<u>Theft of License Plate:</u> On June 27, 2023, at approximately 9:48 AM, an Officer was dispatched to the 2000 block of Tsushima St for a report of a stolen license plate. The victim stated today he observed his rear license plate was missing from his 2015 Black Infiniti Q50. The victim stated he last saw the license plate, on his vehicle, on June 23, 2023 and does not know where the theft occurred. Plate entered into the Stolen Vehicle System. **Case H23-00651**

<u>Fraud</u>: On June 27, 2023, at approximately 11:11 AM, Detectives took a case regarding a previously reported lost/stolen wallet. The investigation indicated a 33 year old male used the victim's credit cards without the owner's permission, **Case 23-00654**

<u>Traffic Collision:</u> On June 27, 2023, at approximately 4:50 PM, Officers were dispatched to an injury collision that occurred in the Creekside shopping center. Officers determined a USPS mail truck had been T-boned by a Toyota Sequoia. The USPS truck was making a left turn to go to the rear of the shopping center when the Sequoia continued straight, striking the mail truck. The 30 year old male driver, of the mail truck, sustained moderate injuries to his arms and face. The 56 year old male driver of the Sequoia, was not injured. The mail truck driver was transported to a local hospital for his injuries. The mail truck was towed by a private tow company. **Case 23-00655**

<u>Driving Under Influence:</u> On June 27, 2023, at 11:12 pm, an officer conducted a traffic stop on a vehicle. Upon contact, the 39 year old male driver, of Rodeo, displayed objective symptoms of intoxication. The subject was given the Standard Field Sobriety Test. The Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. The subject was arrested and transported to Pinole PD for a Breath test. The subject was later cited and released to a responsible party. The vehicle was left legally parked on scene. **H23-00657.**
