Injury Collision: On June 28, 2023 at 9:54 AM, officers were dispatched to a two vehicle collison on San Pablo Avenue near the exit to the Safeway shopping center. Officers contacted the 79 year old female driver of a 2007 BMW. The investigation indicated she failed to stop at a red light and collided into a 2023 Tesla driven by a 40 year old female. The driver of the BMW sustained a minor laceration to her arm. She was treated by AMR and released on scene at her request. The driver of the Telsa indicated she was uninjured and declined medical attention. The Tesla was driven from the scene with minor damage. The BMW was towed from the scene by Tripe A. Case H23-00658

Occupied Stolen Vehicle Recovery: On June 28, 2023 at 4:15 PM officers received a FLOCK notification of a stolen red Hyundai Sonata, driving North on Willow Avenue near the 1200 block of Willow Avenue. An officer located the vehicle stopping at the 76 gas station in the 800 block of Willow Ave. The 27 year old female passenger was outside the vehicle beginning to pump gas. The 44 year old male driver exited the driver seat and, upon seeing officers, fled on foot towards Willow Food and Liquor. The first officer remained with the vehicle and the passenger. Responding officers were able to locate and detain the male driver as he attempted to flee. The car had sustained heavy ignition damage and was filled with drug paraphernalia, possible stolen merchandise, and burglary tools. All evidence was recovered. The male is on parole for robbery. The female passenger is on Probation out of San Joaquin also for robbery. The male was arrested and transported to the Martunez Detention Facility. The female was released on scene. Case H23-00660

<u>Domestic Violence:</u> On June 28, 2023 at 5 54 pm, officers responded to the 500 block of Atlas Drive for a report of a physical fight between a married couple. Officers contacted a 27 year old male outside of the home. The subject advised he had gotten into a physical altercation with his 50 year old husband. The subject advised there was currently nobody in the residence. Officers conducted a protective sweep and located the 50 year old (victim) in his bedroom. Through investigation and observation of injuries, on the 50 year old, it was determined the 27 year old was the dominant aggressor. Evading/Hit & Run/ Possession of Firearm On June 29,2023 at 4:26 AM officers received a Flock notification of a stolen license plate. The plate was affixed to a gold colored Mercedes 4-Door. An officer attempted to conduct a traffic stop on the vehicle, on San Pablo Avenue at Hercules Avenue. The unidentified driver failed to yield and fled from the officers. Officers trailed the vehicle and did not engage in a pursuit. The driver continued by driving wrong way on San Pablo Avenue. Eventually the driver crashed into a tree on the northwest corner of the Safeway Parking lot. Three firearms were recovered from the vehicle. The two passengers were arrested for possession of the firearms. The driver was not located.
