Towed Vehicle: On July 3, 2023, at approximately 10:59 AM, parking enforcement checked on a previously tagged 2004 Chevrolet Colorado, parked in the 2100 block of Lupine Rd. The vehicle was towed for parking beyond the legal time limit. **Case 23-00681**

Collision: On July 3, 2023, at approximately 2:53 PM, A Hercules Police Department employee was involved in a minor collision in Creekside Shopping Center in front of Creekside Cleaners. IP- An adult female driver was attempting to enter a parking spot when the City employee, in a City vehicle, was attempting to exit a parking spot. The female driver's 2018 Honda struck the Department's Ford Explorer leaving minor damage. No injuries were reported. **Case 23-00682**

Organized Retail Theft/ Towed Vehicle: On July 3, 2023, at approximately 5:48 PM, Officers were dispatched to Home Depot for a report of an in-progress theft occurring. Home Depot Loss Prevention stated they watched as two subjects selected merchandise and then one subject pushed the merchandise out of the store without making an attempt to pay. The subjects then entered into a gray Ford Fusion and drove out of the parking lot. Officers intercepted the vehicle as it entered onto westbound I-80. The Fusion yielded for officers and both occupants, matching the description given by the reporting party, were detained. An in-field show up was conducted with positive results and a desire to prosecute. A 30 year old female, and a 54 year old male, of San Pablo, were placed under arrest for organized retail theft. The merchandise taken was multiple packages of batteries, various tools, multiple packages of screws and mulch. The Ford Fusion was towed on scene. For registration violations. Both subjects were cited and released on scene with their respective charges. **Case 23-00683**

Grand Theft: On July 4, 2023, at approximately 1:34 PM, an Officer was dispatched to the 1200 block of Hercules Ave for a report of a theft from a vehicle overnight. The victim stated approximately \$4,000 to 5,000 dollars' worth of tools were taken from the toolbox located in the bed of his truck at approximately 2:27 AM this morning. Surveillance footage of the incident showed a white Toyota Sienna pulling up and a solo male exit the driver's door of the Toyota, and commit the theft. **Case 23-00684**
