Towed Vehicle : On July 10, 2023, at approximately 9:56 AM, an Officer checked on an RV, a 1976 Dream Sportsman, registered to out of Rodeo. The vehicle was stalled on San Pablo Ave at lower Victoria Crescent West. The RV was blocking a lane of traffic and there were no occupants inside or around. The RV was towed as it was a hazard to other traffic. **Case 23-00694**

Forgery/ Defrauding an Inn Keeper: On July 10, 2023 at approximately 4:39 PM, Officers were dispatched to the 100 block of Hawk Ct, regarding a Taxi driver that had been paid with a false check. Officers determined the Taxi driver was given a half filled check that he could cash, and the driver did not believe the check belonged to either of the 3 subjects he gave a ride to. Officers attempted contact with the residents, , but no one answered. The backyard had a smoldering BBQ that appeared to have just been used. A case was taken for investigation into who provided the driver with the false check. **Case 23-00695**

Domestic Violence: On July 10, 2023, at approximately 5:39 PM, Officers were dispatched to the 300 block of N Wildwood for a report of a male and female fighting in front of the residence. Officers arrived and detained two individuals. Officers determined a 32 year old male victim and a 22 year old female suspect got into a physical altercation after an argument. The victim was was bitten by the suspect and the suspect also punched two other parties when they tried to break up the fight. An Emergency Protective Order was granted to the victim. The suspect was arrested and transported to the Martinez Detention Facility. **Case 23-00696**

Failure to Yield / Resisting / Driving Under Influence: On July 10, 2023, at 10:35 pm, an officer attempted a traffic stop on a black Dodge Challenger near 800 Willow. The driver of the vehicle, later identified as a 29 year old male of Hercules, continued driving slowly and obeyed traffic laws all the way to a parking space in the 100 block of Paradise Dr. Once the vehicle stopped the driver remained in his vehicle and would not comply with announcements, over the PA, to exit the vehicle. The driver eventually stepped out of the vehicle but refused to comply with officer's verbal commands. Officers attempted to detain the subject, but he resisted. After a struggle the subject was successfully arrested. The subject displayed symptoms of intoxication and was transported back to HPD for further investigation. Due to the subject's previous disruptive behavior, an abbreviated Standard Field Sobriety Test was conducted. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. The charge of Driving Under the influence was added to the Failure to Yield and Resisting charges. The subject was later cite released to a responsible party **H23-697**.
