**Robbery with Force or Fear:** On July 17, 2023, at approximately 7:40 AM, Officers were dispatched to Lucky supermarket regarding a fight in progress. The reporting party stated a suspect left in a White vehicle with a partial license plate given. The Officers arrived and determined employees had attempted to stop a female suspect from stealing items from the store. The suspect punched one of the employees in the face and back of the head. The suspect fled, in a White vehicle, with the stolen merchandise. A Flock search revealed a 2004 White Acura TL, matching the description of the suspect vehicle, was registered to a female living in the 300 block of Violet Rd, in Hercules. Officers responded to the address and located a 20 year old female, matching the suspect's description, unloading stolen merchandise from a vehicle into a residence. The suspect was detained and positively identified, in an in-field show-up, as the person who stole items from Lucky and assaulted an employee. The merchandise was recovered and returned to Lucky. The suspect was arrested, for Robbery, and transported to the Martinez Detention Facility. The victim of the assault sustained minor injuries to the face and head. The victim was evaluated by AMR and released. **Case 23-00721**

**Warrant Arrest/ Possession of a Controlled Substance:** On July 17, 2023, at approximately 9:40 AM, an Officer conducted a traffic stop on a White GMC Tahoe in the 1500 block of Sycamore Ave. The 33 year old male front passenger, of San Pablo, was found to have a no-bail, Parolee at Large, warrant. A probable cause parole search of the vehicle was conducted. Located in the center console was approximately 1.5 Ounces of suspected Fentanyl. The 39 year old male driver, of Pittsburg, was determined to be the person in possession of the above narcotics. The passenger was arrested, for the warrant, and transported to the Martinez Detention Facility. The driver was arrested, cited, and released on scene, for the narcotic possession. **Case 23-00722/23-00723**

**Towed Vehicle:** On July 17, 2023, at approximately 3:40 PM, an Officer checked on a vehicle parked in the Safeway parking lot. The vehicle, a 2008 Chevrolet Silverado, was found to have expired registration (March of 2016). The vehicle was towed for registration violations. **Case 23-00724**

**Mail Theft:** On July 18, 2023, at 3:16 am, officers were dispatched to the area of Windsor and Bristol for a report of two subjects opening mailboxes. The subjects were described as, wearing black hoodies, and last seen walking towards Bristol. Officer arrived in the area and observed several open mailboxes at the intersection of Windsor and Dover. During an area check, a 33 year old female, wearing a black hoodie, was located looking into vehicles on Bristol. The female was detained after attempting to walk away from officers. The subject was in possession of a bag containing several articles of mail from residences in the area. The mail was not in addressed to the subject. The subject was also in possession of a knife and screwdriver (items commonly used to break into mailboxes and vehicles). The subject was placed under arrest. During further check several articles of mail, from the area, were located

on the ground near parking stall on Bristol. The subject was transported to the Martinez Detention Facility. The mail was collected for return to the Postal Inspector. **H23-00725.**
