Missing Person Report: On July 21, 2023, at 11:44 a.m. the Reporting Party (RP), 32 year old male, called Hercules Police to report his fiancé, 29 year old female subject (SUB), missing. According to the RP, SUB has been transferred to multiple different facilities. All the facilities would not release SUB's status or location to the RP. Officers attempted to contact the County Regional Medical Center and Adventist Health Vallejo where SUB was reportedly admitted. The facilities could not confirm whether or not SUB was ever a patient of theirs. RP advised that SUB has been using a false identity. A case was taken, and SUB was entered into MUPS. Vallejo PD was advised of the situation and to be on the lookout. **H23-00734**

Violation of Court Order: On July 21, 2023, at 7:05 p.m., officers responded to the 1300 block of Chelsea for a report of a court order violation. The juvenile victim's father stated his son was being harassed by a juvenile subject, who he had a restraining order against for a prior assault. The father reported his son called him to say the subject was in the complex in violation of the order and followed as he walked to Willow Food and Liquor. The father responded and picked his son up in his vehicle while the subject, who was accompanied by another friend, went inside Mountain Mikes Pizza. Officers responded to the area but did not locate the subject in Mountain Mikes. At 7:45 p.m., the father called again and stated the subject was standing outside of Willow Food and Liquor. Officer responded to the area where they detained the subject and placed him under arrest. The subject was transported back to HPD and Juvenile Hall was contacted. Juvenile Hall stated they would not accept the subject on a non-felonious court order violation and advised to cite release him. The subject's parents responded to HPD where they took custody of him after his signed promise to appear. **H23-00736**

Driving on Suspended License for Driving Under the Influence: On July 22, 2023, at 8:25 a.m., an officer conducted a traffic enforcement stop on a 2012 Chevrolet Malibu for a vehicle code violation. The driver, 22 year old male out of San Pablo, was found to be driving on a suspended license for Driving Under the Influence. The subject was cited and released on his signed promise to appear, and his vehicle was parked. **H23-00737**

Miscellaneous Information/ Missing Person Located/Returned: On July 23, 2023, at 1:03 a.m., Officers were dispatched to the 200 block of Newbury Street for a welfare check. The Reporting Party (RP), 25 year old female, stated her boyfriend, 24 year old male of Hercules, left the residence approximately 5 hours ago in a silver Honda Pilot and had not returned. The subject (SUB) texted the RP stating he was going to harm himself and he would not be returning home. Due to previous mental health issues, a ping of his cell phone was conducted which showed him driving in Martinez. Officers were unable to contact SUB. SUB has no weapons, and it is unknown how he plans to harm himself. **H23-00738**

Supplement to Case H23-00738: On July 23, 2023, at approximately 7:37 a.m., the RP from last night's Miscellaneous Information Report, called in and requested we enter SUB, as a

missing person. SUB was entered into MUPS and a short time later the RP called in and stated he had arrived home and was now asleep. Officers responded to the 200 block of Newbury Street and conducted a mental health evaluation of SUB. SUB was deemed to be a danger to himself. AMR arrived on scene and transported SUB to the County Regional Medical Center. **H23-00738**

Towed Vehicle/ Obstructing, Delaying, Resisting a Peace Officer: On July 23, 2023, at approximately 5:11 p.m., an Officer checked on a suspicious, occupied vehicle (2000 Honda Accord) in the Home Depot parking lot. The Officer observed a 2023 tab on the rear license plate despite the vehicle being last registered in 2020. The Officer contacted a 53 year old male, of Alhambra, in the driver's seat. The subject (SUB) was passively noncompliant during the contact and refused to understand why Officers were speaking with him. SUB was advised the vehicle would be towed for registration violations. An Officer conducted an inventory search of the vehicle and nothing illegal was found. SUB was advised to gather items he may need. While gathering his items, SUB advised Officers he was going to stay in his vehicle and refuse to exit the vehicle and he wished to go to the tow yard with his vehicle. After approximately 15 minutes of talking with SUB, asking him to exit the vehicle and explaining what could happen, SUB continued to refuse lawful orders and delay Officers and became more aggressive and threatening. Ultimately SUB was removed from his vehicle and placed into handcuffs with minimal force used. SUB was then placed under arrest. No Officers were injured. SUB was transported to Martinez Detention Facility without incident.

Probation Violation/ Driving on a Suspended Driver's License with prior Driving Under the Influence's: On July 23rd, 2023, at 10:15 p.m., an officer conducted a suspicious vehicle check on a gray Dodge Ram 1500. The Dodge had stalled in the intersection of John Muir Parkway at San Pablo Avenue. The driver, 61 year old male, parked the vehicle partially in the roadway on San Pablo Avenue in front of Safeway. The officer conducted a suspicious vehicle check and determined the subject was on searchable probation out of Contra Costa County and had a suspended driver's license for driving under the influence of alcohol. The subject was placed under arrest and cited and released on scene. Officers assisted the subject in getting his vehicle out of the roadway and into the Safeway parking lot. **H23-00740**

Possession of a Controlled Substance: On July 24, 2023, 9:59 a.m., an Officer checked on a suspicious vehicle parked in the 800 block of Willow Ave. The Officer watched as a 38 year old male, of Valley Springs, set-up tin foil to smoke suspected heroin. The Officer detained the subject and conducted a probable cause search of his 2012 Volkswagen Passat. The Officer located various amounts of suspected Methamphetamine, suspected Heroin, and suspected ecstasy. The subject was cited and released on his charges. **H23-00741**

Miscellaneous Information: On July 24, 2023, at 8:14 p.m., a 55 year old male of Hercules, turned in three firearms in order to be in compliance with his served domestic violence court order. **H23-00742**

Warrant Arrest: On July 24, 2023, at 9:16 p.m., Officers were dispatched to the 1000 block of Lavender Place for two occupied suspicious vehicles. Officers contacted a 25 year old male of Hercules, sitting in the driver's seat of his red Hyundai Elantra. The subject (SUB) was determined to have an outstanding non-cite able felony warrant out of Hercules PD. SUB was transported to Martinez Detention Facility without incident. The Elantra was released to a family member of SUB, who was also on scene. **H23-00743**
