<u>Stolen Vehicle:</u> On July 27, 2023, at approximately 7:26 AM, an Officer was dispatched to the 1000 block of Regatta Point for a report of a stolen vehicle. The Officer spoke with the Reporting Party/Victim (RP/V), 46 year old male, who stated that his 2016 Dodge Challenger Hellcat was stolen. <u>Court Order Violation:</u> On July 28, 2023, the Reporting Party (RP), 43 year old female from Vallejo, arrived at HPD to report her son's father, 36 year old subject (SUB) from Sacramento, had not dropped their son off as directed in a served court order. SUB initially had refused to drop off the child and claimed the drop-off was supposed to be on Sunday. <u>Miscellaneous Information:</u> On July 28, 2023, at 8:08 PM, the Reporting Party (RP), 29 year old female from Berkeley, arrived to HPD to report possible child molestation. RP has a three-year-old son and is separated from the father. She stated when her son comes home from his father's house, he says inappropriate sexual things and touches himself in inappropriate ways for his age. The father was identified as a 32 year old male subject (SUB) of Hercules. The child does not have any visual injuries or trauma, which was confirmed by a doctor she visited yesterday. Officers contacted a Judge who granted an Emergency Protection Order for the child, and Child Protective Services was contacted. **H23-00761**

<u>Possession of Methamphetamine:</u> On July 28, 2023, at 10:01 PM an officer checked on a suspicious Honda parked in front of Safeway at 4080 San Pablo Avenue. Officers contacted three subjects in the vehicle. During a probable cause search, one of the occupants, identified as 34 year old male from Pittsburg, was found to be in possession of suspected Methamphetamine. The subject was cited and released on scene. **H23-00762**

<u>Domestic Violence/ False Imprisonment/ Strangulation:</u> On July 28, 2023, at 10:27 PM officers responded to the 100 block of Cinnabar Way for a domestic dispute. The 12-year-old son reported his parents were fighting and believed one of them had been stabbed. Officers

separated and detained both parents and rendered the child safe. The father, 51 year old subject (SUB), had two stab wounds to his body. The mother, 47 year old victim (V), had bruising to her neck and complaint of pain throughout her body. We provided medical aid to both on scene. SUB was transported by AMR to John Muir Walnut Creek and was later arrested and transported to Martinez Detention Facility. V was transported to a hospital for further medical attention. Child Protective Services was contacted for their son, and he was picked up by a family member who took custody of him at this time. An Emergency Protective Order was granted and served. **H23-00763**

<u>Incident 23-40:</u> On July 29, 2023, at 8:00 AM Hercules officers responded to the 1000 block of Sanderling Drive to serve an Emergency Protective Order to a 32 year old male subject (SUB). SUB was contacted outside his residence and advised of the terms of the order. SUB was given a hard copy of the order in person, and he acknowledged he understood the terms. The order was faxed to Dispatch to be input into the system.

<u>Warrant Arrest x2:</u> On July 29, 2023, at 8:22 PM, an Officer conducted a traffic enforcement stop on a no plate Acura MDX on San Pablo Ave at Tsushima.
