Warrant Arrest: On July 31, 2023, at approximately 12:56 PM, an Officer conducted a traffic enforcement stop on a 2004 Volvo S80. The driver, 34 year old male out of Alameda, was contacted and found to have an outstanding no cite warrant issued by Vallejo PD. The subject was also driving on a suspended driver's license and was issued a citation for that violation. The Volvo was towed, and the subject was transported to Martinez Detention Facility without incident. **Case H23-00770**

Shoplifting/Resisting Arrest/Possession of a Controlled Substance and Drug

Paraphernalia: On July 31, 2023, at approximately 4:10 PM, Officers were dispatched to a theft in progress at Home Depot. The Reporting Party stated the suspect was a male with a backpack filled with merchandise. The male was last seen walking towards Taco Bell. An Officer located the suspect in the middle of the intersection of 1500 Sycamore Ave. The suspect began to resist the Officer's detainment. Units arrived on scene and the suspect was taken into custody. The suspect was identified as a 39 year old male out of Richmond. Home Depot confirmed his theft of various tool attachments and desired prosecution as well. A search of his person yielded suspected Methamphetamine and Drug paraphernalia. The suspect was transported to Martinez Detention Facility without incident. **Case 23-00771**

Warrant Arrest: During the above incident, Officers located a green 2007 Ford F-150 parked in the Home Depot parking lot. The Reporting Party advised the above suspect was also with subjects associated with this Ford truck. An Officer contacted a 31 year old male, out of Livermore, who was seated in the truck. The subject (SUB 1) was found to have two no cite outstanding warrants issued by Solano County SO and Foster City PD. A second subject (SUB 2) walked up to the truck while Officers were on scene and was contacted. SUB 2 had purchased his merchandise and was clear of wants/warrants. A search of the truck was conducted for stolen merchandise. Suspected stolen merchandise was located however Home Depot could not confirm the theft. SUB 1 was transported to Martinez Detention Facility without incident. SUB 2 was given permission by SUB 1 to take possession of the truck. **Case 23-00772**
