Auto Burglary: On August 15, 2023, at approximately 7:23 AM, an Officer responded to the 100 block of Chestnut Drive for a reported auto burglary. The Reporting Party/Victim (RP/V), 59 year old male, stated his GMC Canyon and Honda sedan were both burglarized last night. Three unknown suspects, at approximately 2:55 AM, arrived in front of his house and then exited an early 2000's black Chevrolet Tahoe. The suspects then make entry into both vehicles and steal miscellaneous tools and cash. The suspects then leave the area in the Tahoe. The license plate attached returns on a Cadillac SUV out of Richmond and believed to be an unreported stolen license plate. The Registered Owner of the Cadillac has yet to be contacted.
