**Warrant Arrest:** On August 17, 2023, at 8:24 PM officers patrolling VSET in Pittsburg conducted a traffic enforcement stop on a Toyota Camry no plates. The driver was identified as a 35 year old female from Nevada and she was found to have a misdemeanor warrant out of Vacaville. She was arrested and transported to Martinez Detention Facility. **H23-00830**

**Recovered Stolen Vehicle/ Burglary Tools and Warrant Arrests:** On August 18, 2023, at 7:15 AM, officers received a Flock notification of a stolen vehicle traveling South on San Pablo Ave, an officer located the 2002 Chevy Tahoe at San Pablo Ave and Del Monte Dr. in Pinole. The driver of the vehicle saw the officer and took off into the Bayview neighborhood at a high rate of speed. Officers did not pursue the vehicle. Other officers responded to the area and looked for the vehicle. While enroute, an officer located the vehicle smoking with a flat tire in front of 855 San Pablo Ave. (Gables Motel), with an adult male exiting the front passenger seat and an adult female exiting the driver's seat. The officer detained the male suspect, and the female ran into a front yard on the 800 block of San Pablo Ave., where she hid behind a garbage can and was located and detained shortly after. While the male was being detained, a passerby told the officer two subjects were standing in the driveway of the Gables Motel that were the back seat passengers of the vehicle; they were also detained. The driver was identified as a 37 year old female subject (SUB 1) out of Oakland, Front passenger was a 40 year old male subject (SUB 2) out of Oakland, Rear passengers were a 48 year old male subject (SUB 3), and 22 year old female subject (SUB 4) out of Oakland. While Officers were conducting the investigation and waiting on a tow truck, the vehicle caught on fire and engulfed the whole engine compartment. Con Fire Engine 73 responded and extinguished the fire. The vehicle was towed. SUB 4 was released, SUB 2 was cited and released for an outstanding warrant **H23-00832**, SUB 3 was transported to Martinez Detention Facility (MDF) for outstanding warrants **H23-00833**, and SUB 1 was transported to MDF. **H23-00831**

**Shoplifting:** On August 18, 2023, at 4:04 PM, officers were dispatched to Lucky at 1590 Sycamore Ave. for a report of a theft that had just occurred. The reporting party reported two females just stole from the store and left in a white Nissan Rogue. An officer conducted an area check for the vehicle and located it parked in front of Safeway at 4080 San Pablo Ave. The officer detained the two occupants, 21 year old female subject (SUB 1) out of San Pablo and 29 year old female subject (SUB 2) out of San Pablo. Lucky wished to press charges for the stolen merchandise, and an in-field show-up was conducted with positive identity for both. SUB 1 was arrested and released on her signed promise to appear. SUB 2 was released. **H23-00834**

**Robbery:** On August 18, 2023, at 7:29 PM officers responded to Chase Bank at 4040 San Pablo Avenue for a robbery. While enroute officers were notified that the Reporting Party/Victim (RP/V), 34 year old male, had left the area and was calling from home in the 200 block of South Wildwood. RP/V stated he was at Chase taking out money when he was

confronted by four males wearing ski masks. One of the suspects was armed with a handgun which he pointed at RP/V's face. The suspects took RP/V's wallet and cash. The suspect vehicle was described as a newer Honda CRV. Officers did an area check for the vehicle and checked flock with negative results. RP/V sustained no injuries during the incident. **H23-00835**

**Collision** On August 19, 2023, at 1:10 AM officers responded to Victoria Crescent West and South Shelter Bay for a report of a solo vehicle collision. Officers located a red Ford hatchback in the middle of the intersection disabled. The driver and solo occupant was identified as an 18 year old female from Hercules. The subject fell asleep and collided with a light pole. There were no signs of intoxication or drug use. **H23-00836**

**Warrant Arrest /Transport:** On August 19, 2023, at approximately 11:00 AM, an officer responded to Santa Clara County Jail to pick up 48 year old male on an outstanding warrant. The subject was transported to Martinez Detention Facility. **H23-00837**

**Towed Vehicle:** On August 19, 2023, at approximately 11:48 AM, an officer conducted a traffic enforcement stop on a 2014 Mazda at Safeway Gas, 4000 San Pablo Ave. The driver was identified as a 26 year old subject out of Lathrop. The vehicle was towed for expired registration over 6 months and the subject was released. **H23-00838**

**Coroner's Case:** On August 20, 2023, at 1:51 AM, officers responded to a medical call at the 1100 block of Rock Harbor Pt, regarding a male who fainted with shallow breathing. Fire and AMR were already on scene, and the 77 year old male was pronounced deceased at 2:07 AM. The deceased body was released to family by the Coroner **H23-00839**

**Theft of License Plate:** On August 20, 2023, at approximately 3:02 PM, the Reporting Party/Victim (RP/V), 56 year old female, arrived at the Hercules police lobby to report her front license plate missing. RP/V stated on 08-18-2023 at 9:00 PM she last saw her front license plate attached to her vehicle. This morning she observed her license plate was missing. The license plate, belonging to the 2022 Black Hyundai Santa Cruz, was entered into SVS. **H23-00840**

**Driving Under the Influence:** On August 20, 2023, at 8:16 PM, officers responded to the area of Home Depot for a welfare check on a female, passed out behind the wheel of a white Mercedes. An officer located a 50 year old female in her white Mercedes on the Creekside Center exit across from 1500 Sycamore. Upon contact, the subject (SUB) displayed symptoms of intoxication and had an open alcoholic beverage container in the cup holder. SUB could not answer simple questions or follow simple instructions and became passively resistive when taken out of the vehicle to perform sobriety tests. SUB was placed under arrest for driving under the influence and was transported back to HPD where she refused sobriety tests. A records check on SUB revealed she was on DUI probation out of Contra Costa County. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. SUB was transported to Martinez Detention Facility where she was booked without incident. The vehicle was towed. **H23-00841.**

**Prisoner Transport:** On August 20, 2023, at 7:26 PM, an officer responded to San Mateo County Jail to pick up a 54 year old male for a Hercules Warrant. The subject was transported to Martinez Detention Facility where he was booked without incident **H23-00842.**
