**Driving Under the Influence/Driving on Suspended License for DUI:** On August 23, 2023, at 8:29 am, an officer conducted a traffic enforcement stop on a 2007 Ford for vehicle code violations on Willow Ave at Cambridge. The driver, 40 year old male out of Hercules, was found to be driving on a suspended license for DUI and was also found to be driving under the influence of alcohol. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving and was arrested for DUI. The subject (SUB) was also on DUI probation. SUB was transported to HPD for a blood draw and was cited and released on his signed promise to appear. **H23-00850**

**Towed Vehicle:** On August 23, 2023, at 10:50 am, an officer checked on an abandoned vehicle parked on the 200 block of Violet Rd. The 2001 Gray Lexus RX300 was found to be expired in 2021. The vehicle was towed. **H23-00851**

**Possession of Controlled Substance:** On August 23, 2023, at 12:26 pm, an officer conducted a traffic enforcement stop on a 2005 Saturn Vue for vehicle code violations. The driver, 32 year old male subject (SUB 1) out of Concord, was found to be on searchable probation. The passenger, 33 year old female subject (SUB 2) agreed to a consent search of her bags and suspected methamphetamine was in a bag belonging to SUB 2. SUB 2 was cited and released on scene with her signed promise to appear. **H23-00852**

**Shoplifting and Contributing to the Delinquency of a Minor:** On August 23, 2023, at 4:05 pm, officers were dispatched to Rite Aid for a theft that had just occurred. The suspect was described as an adult male in black clothing carrying a bag and there was a female with him. An officer located the suspects walking on Sycamore near San Pablo Ave. Rite Aid confirmed they wanted to press charges and the male was detained. Stolen items were located in the male's bag, and it was determined the female with him was his 13 year old daughter. The 44 year old male, out of Pinole, was arrested and later cited and release on his signed promise to appear. **H23-00853**

**Mental Health Evaluation:** On August 23, 2023 at 9:44 pm, Officers were dispatched to a house in the 100 block of Tuscany for a verbal argument with a caretaker who lives in the home. The caretaker, 57 year old female of Modesto, made statements that she wanted to harm herself.
