Warrant Arrest: On August 24, 2023, at 8:30 am, an officer conducted a traffic stop on a Dodge truck, for vehicle code violations, in the Creekside Shopping Center. One of the occupants was found to have a citable warrant out of Marin County. The 33 year old male, out of Richmond, was arrested, cited, and released. **H23-00855**

Towed Vehicle: On August 24, 2023, at 9:08 am, an officer conducted a traffic stop on a Gold 2003 Cadillac CTS, with no plates, near Safeway. The vehicle registration was found to be expired in 2020 and had a non-operational status. The vehicle was towed for the registration violation. **H23-00856**

Fraud: On August 24, 2023, at 10:11 am, an officer was dispatched to the Lobby of HPD for a Fraud report. The victim stated an unknown suspect obtained her Bank of America Debit Card information and stole money out of her account. **H23-00857**

Fraud: On August 24, 2023, at 3:33 pm a resident came to HPD for a report of a fraud. The victim stated a message came up on her computer that it had a problem. She allowed a person, who she thought was Geek Squad, to have remote access to her computer and she also paid them with \$250.00 in gift cards. **H23-00858**

Outside Assist: On August 24, 2023, at 4:19 pm officers were made aware that Richmond PD was in pursuit of an Armed Robbery Suspect. Richmond Stated the vehicle was last seen exiting Willow Ave but they lost sight of it. At 4:23 pm, dispatch received a call from a citizen stating they saw two subjects running from a vehicle towards Valley Bible. Officers arrived on scene shortly after and saw two subjects running into the brush area between Hwy 4, Caltrans, and Valley Bible. Hercules Officers quickly detained a 17 year old male, and an 18 year old male, both from Vallejo. RPD arrived and took custody of the two males. **H23-00859**

Stolen Vehicle: On August 24, 2023, at 5:21 pm, an officer was dispatched to HPD for a stolen vehicle report. A representative from Penske reported a Ford Van, with an Indiana Plate, was never returned after being rented in April. The vehicle is yellow with Penske written on the sides. The vehicle last hit Flock two days ago in Vallejo. The van was entered into the Stolen Vehicle System. **H23-00860**

Miscellaneous: On August 25, 2023 at 7:04 PM officers responded to a possible kidnapping at the Shell Gas Station at 3900 San Pablo Avenue. Reporting party stated he witnessed a

female get forced into a gray Ford Truck by a male adult. The vehicle left in an unknown direction. Officers were posted at exit/entry points of the City and circulated with negative results. Officers also checked addresses associated with the truck in Richmond and Vallejo. After further investigation it was determined it was a verbal argument, and the Reporting Party clarified the female got into the truck willingly and never saw her physically assaulted. The kidnapping was unfounded. A case was taken form documentation. **H23-00862**

Mental Health: On August 25, 2023 while an officer was conducting a traffic stop at 800 Willow Avenue, he was approached by a distraught 47 year old female, of Rodeo. She stated was being followed by a 41 year old male also of from Rodeo. The female stated she feared for the male's safety due to him being intoxicated, walking in traffic, and unable to care for himself. The male was contacted and had cut marks on his arms. The male was transported to the County Regional Medical Center by AMR for an evaluation. **H23-00863**

Possession Of Controlled Substance: On August 25, 2023 at 11:22 PM officers working collaborative enforcement conducted a traffic stop on a Honda at Safeway at 4000 San Pablo Avenue. The 34 year old female passenger, of Redding, was in possession of controlled substances and paraphernalia. The female was arrested, cited and released. **H23-00864**

Officers contacted the 51 year old male, of Hercules. The subject was found to be unsafe and a danger to himself and others. The subject was transported to the County Regional Medical Center, by AMR, for an evaluation. **H23-865**

Found Property On August 26, 2023 at 1:16 AM an officer conducted a pedestrian stop on 41 year old male, of Walnut Creek. The subject was pushing a small engine motorbike with plates belonging to a Harley Davidson. The plate returned clear in SVS and it was taken as found property. **H23-866**

Outside Assist On August 26, 2023 at 3:50 AM officers responded to 4000 San Pablo Avenue to assist Fairfield PD with a pursuit. Fairfield was chasing a stolen red Hyundai Sonata, and a firearm had reportedly been tossed from the vehicle during the pursuit. The vehicle yielded at Safeway and the driver was detained. The passenger fled from the vehicle and was last seen running into the ravine between San Pablo Avenue and South Front Street. A perimeter was set and with the assistance of San Pablo PD K9, and other agencies, officers located the 35 year old male suspect, from Oakland, hiding up in a tree at the corner of Sycamore Avenue and San Pablo Avenue. Warrant Arrests: On August 26, 2023, at 9:54 am, an officer conducted a traffic stop on a 1996 Chrysler Town and Country, for expired registration, at 800 Willow Ave. The occupants were contacted. A 40 year old male, of Richmond, was found to have a warrant out of Marin County. Another occupant of the vehicle, a 31 year old male out of Fairfield, was found to have three outstanding warrants out of Solano County. Both subjects were arrested and transported to the Martinez Detention Facility. The vehicle was towed for expired registration. **H23-00867**

Officers cotacted the victim who stated a female, in a red Kia, hit him behind. The driver of the Kia was last seen on the Safeway parking lot. The victim was able to get a photo of the vehicle, the plate, and the female driver. The plate was temporary plate which came back to an address on Bayfront

Blvd. Officers attempted contact however she was not home. An officer was later able to contact her via telephone. The victim wished to press charges for hit and run and signed the CA. **H23-00868**

Stolen Vehicle Recovery: On August 27, 2023 at 5:52am, officers received a FLOCK notification of a stolen gray Hyundai SUV, traveling west on Hercules Avenue towards Titan. An officer located the Hyundai, unoccupied, on Woodfield and Williams. The vehicle was recovered and removed from the Stolen Vehicle System. **H23-00869**

Warrant Arrest: On August 27, 2023, at approximately 3:55 PM, an Officer conducted a traffic stop on a white 2000 GMC Sierra, with no plates. The 53 year old female driver, of Oakland, was found to have a cite releasable warrant held by Marin CO SO. The subject was arrested, cited, and released. **Case 23-00870**

Towed Vehicle/Driving on a Suspended License: On August 27, 2023, at approximately 4:53 PM, an Officer conducted a traffic stop on a 2010 silver Nissan Altima CA-.
