Towed Vehicle: On August 28, 2023, at approximately 1:33 PM, Officers were dispatched to Lupine Rd at Sequoia Rd for a report of a vehicle collision. Officers arrived on scene and determined a non-injury solo vehicle collision occurred. The primary driver's Toyota Camry was blocking the roadway and disabled. The vehicle was towed. **H23-00872**

Violation of Domestic Violence-Restraining Order (DV/RO)/Vandalism: On August 28, 2023, at approximately 3:13 PM, the 33 year old Reporting Party/Victim (RP/V) arrived at the Hercules PD lobby to report a restraining order violation. RP/V is currently living in the 200 block of Oriole Ct with her new boyfriend. RP/V stated that her ex-boyfriend came into Hercules at approximately 3:44 AM and smashed a window out on her vehicle. The ex-boyfriend, 33 year old male, left her a voice message stating that her vehicle windows are smashed out and he doesn't know why. The contact and vandalism are both in violation of the terms in the DV/RO. **H23-00873**

Miscellaneous Information: On August 28, 2023, at approximately 4:45 PM, Rodeo-Hercules Fire Department requested Police assistance while on a medical call in the 1000 block of Regatta Point. Officers arrived and contacted a 34 year old male who had a large laceration to the left side of his head. The subject (SUB) was incoherent and bleeding. SUB was transported to the hospital. There were no obvious signs of foul play or that a crime had occurred. Report taken for documentation. **H23-00874**

Vehicle Collision with Injuries: On August 28, 2023, at 8:53 PM, officers responded to Refugio Valley Road near the roundabout for a vehicle collision with unknown injuries. Officers observed a silver Audi with major front-end damage and the front passenger (PA 1), 21 year old male, trapped in the front seat. The driver (D), 19 year old male out of San Lorenzo, and PA 1's sister, 21 year old female, who was the rear passenger (PA 2), were both out of the vehicle and sustained non-life-threatening injuries. Fire and Medics arrived on scene and were able to extricate PA 1 who was air lifted to the hospital with serious injuries. D and PA 2 were both transported to the hospital by AMR for further treatment. After investigation and obtaining statements, officers determined it to be a solo vehicle collision into a eucalyptus tree caused by unsafe speed entering the roundabout. The vehicle was towed. **H23-00875**

Stolen Vehicle: On August 29, 2023, at 3:57 AM, an officer responded to the 100 block of Boxwood for a report of vehicle theft. The officer contacted the Reporting Party/Victim (RP/V) who stated he heard his 2018 Jeep Grand Cherokee Track Hawk start up and leave his residence at approximately 3:30 AM. RP/V secured his vehicle when he parked it and had all keys accounted for. **H23-00876**

Stolen/Recovered Vehicle: On August 29, 2023, at 5:14 AM, an officer responded to the 1000 block of Avocet for a report of vehicle theft. The Reporting Party/Victim (RP/V) stated he

parked and secured his Subaru Crosstrek on August 28, at 5:00 PM. The officer conducted an area check for the vehicle and located it near the intersection of Earnest and Bayfront.
