Possession of a Controlled Substance/Probation Violation: On August 29, 2023, at approximately 8:21 AM, an Officer conducted a traffic enforcement stop on a 2010 Hyundai Genesis. The Officer contacted a 42 year old male, out of Richmond, who was found to be on Contra Costa searchable probation. Located in the subject's vehicle was a bottle of prescription Promethazine/Codeine not prescribed to him. The subject was cited and released on scene for the violations. **H23-00878**

Stolen Vehicle: On August 29, 2023, at approximately 10:18 AM, an Officer was dispatched to the 2200 block of John Muir Parkway regarding a stolen vehicle. The Officer arrived and contacted the Reporting Party/Victim (RP/V), 60 year old female, who stated her green 1998 Jeep Grand Cherokee was stolen from the secured parking garage. RP/V had last seen her Jeep last night at approximately 9:00PM. Surveillance footage was located of a male wearing a white shirt and black sweatshirt with a backpack who entered the garage on August 29, 2023, at approximately 6:44 AM and then the Jeep exited not long after. Per Flock the Jeep drove around Concord all morning and afternoon. Vallejo PD pursued the Jeep in their city and were able to get a subject in custody. **H23-00879**

Mental Health Evaluation: On August 29, 2023, at approximately 2:50 PM, Officers were dispatched to the 100 block of Shepard St for a report of a male with no shoes digging through trash. Officers contacted a 48 year old male, out of Modesto, and determined he was a danger to himself. The subject was transported to the County Regional Medical Center to be evaluated. **H23-00880**

Warrant Arrest: On August 29, 2023, at approximately 3:51 PM, an Officer observed two females seated in a vehicle parked in the 190 block of Paradise Dr. The Officer contacted a 38 year old female out of Fairfield. The subject (SUB) was found to have an outstanding warrant issued by Pinole PD. SUB was transported to Martinez Detention Facility. **H23-00881**

Theft From Unlocked Vehicle: On August 29, 2023, at 10:44 PM, an officer responded to the 100 block of Pavon for a theft of a purse from an unlocked vehicle. The Reporting Party/Victim (RP/V), 40 year old female, reported she heard her Land Rover's horn honk in front of her residence at approximately 10:00 PM. When RP/V looked outside she saw a white Mercedes SUV parked near her vehicle. RP/V saw the interior light on, and the driver's door of her vehicle partially opened but could not see any suspects. When RP/V returned to her vehicle, she noticed her purse, containing cash and access cards, was missing from the interior. An area check for the white Mercedes was conducted but it was not located. **H23-00882.**

Unattended Death: On August 30, 2023, at 6:26 AM, officers responded to the 2000 block of Redwood Rd, for a report of a male who fell from his bed and unknown if conscious or breathing. Officers arrived on scene and began CPR. Fire arrived on scene to take over

treatment but the patient, 72 year old male, was pronounced deceased at 6:33 AM. The deceased (DE) had several medical conditions and there were no signs of foul play. The coroner released DE's body to his wife. **H23-00883.**
