Shoplifting/Towed Vehicle: On August 31, 2023, at approximately 10:43 am, an officer was dispatched to Rite Aid for a cold theft. The officer was able to locate the suspect vehicle, a grey Mercedes Benz R350, entering the Safeway parking lot. A traffic enforcement stop was initiated and the suspect, 27 year old female, was detained. An in-field show was conducted which positively identified the female as the theft suspect. The stolen merchandise was returned to Rite Aid and the suspect was cited and released on her promise to appear. The Mercedes was towed from the scene for expired registration. **H23-00887**

Miscellaneous Information: On August 31, 2023, at approximately 10:39 am, an officer was dispatched to a lobby detail regarding harassing text messages. The Reporting Party (RP), 80 year old female, advised she hired the subject (SUB), 51 year old male, to conduct some landscaping at her home. SUB has worked for RP for approximately 5 years. Throughout the month of August 2023, SUB has been sending illicit photos of his genitals to RP as well as sending her screenshots of pornography. RP was interviewed but she declined prosecution, nor did she desire a restraining order. RP desired the incident to be documented. An information report was taken for documentation purposes. **H23-00888**

Warrant Arrest: On September 1, 2023, at approximately 1:49 am an Officer conducted a traffic enforcement stop on a 2002 Honda Odyssey. The driver, 22 year old female of Vallejo, was clear of any wants/warrants. The passenger was identified as a 34 year old male, of Vallejo, and determined to have a cite releasable warrant held by the Napa County Sheriff's Office. The male was cited and released on scene with his notice to appear. **H23-00889**

Criminal Threats: On September 1, 2023, at 7:59 am a resident came to the station to report a threat via text message. The Reporting Party (RP) stated a mutual friend sent her a text message stating the suspect was going to harm one of her other friends. The victim was with the RP and all the involved parties go to Hercules High School. A case was taken, and the information was given to the school. The investigation is ongoing. **H23-00890**

Theft of a License Plate: On September 1, 2023, at 8:51 am an officer was dispatched to the 1900 block of Redwood Road for a theft report. The victim stated an unknown suspect stole the plate off his Chevy Bolt. The plate was entered into SVS. **H23-00891**

Warrant Arrest: On September 1, 2023, at 3:04 pm, an officer conducted a traffic stop for a vehicle code violation on a 2013 Ford at the Safeway Gas Station. The driver, 27 year old male out of Union City, was found to have an outstanding warrant. The subject was cited and released on his signed promise to appear. **H23-00892**

Warrant Arrest/Possession of Loaded Firearm: On September 1, 2023, at 3:20 pm, an officer spotted a vehicle with a suspect who was known to have an outstanding Ramey warrant out of Walnut Creek PD. The officer was able to conduct a traffic enforcement stop on eastbound State Route 4 prior to Sycamore Ave. The officer contacted the 39 year old

male, out of Hercules, and learned he had a firearm in the vehicle. The subject (SUB) was arrested and transported to HPD. The vehicle was towed, Walnut Creek PD responded and conducted an interview. He was later transported to Martinez Detention Facility. **H23-00893**

Collision Involving City Vehicle: On September 1, 2023, at approximately 3:18 pm, while attempting to stop the above vehicle an officer was maneuvering around a vehicle in the Safeway parking lot and accidentally side swiped the vehicle at slow speed in the lot. The other party went home and then called the police. The other party, 25 year old female out of Rodeo, later claimed to have some back pain. AMR responded to her house where she declined to be transported and stated she would self-transport if needed. **H23-00894**

Stolen Vehicle Recovery: On September 2, 2023, at approximately 1:49 am, HPD received a Flock hit on a 2008 Cadillac STS in the area of WB Hercules Ave/Titan Way. The Cadillac was reported stolen to Oakland PD on 9/01/23. HPD Officers located the Cadillac occupied in the 2100 block of Railroad Ave. The driver, 30 year old male of Oakland, was detained without incident. The subject was clear of any wants/warrants and transported to Martinez Detention Facility for possession of a stolen vehicle. The Cadillac was released at the scene to the registered owner. **H23-00895**

Outside Assist: On September 2, 2023, at 10:31 am, officers received a flock notification of a wanted suspect driving through town. The suspect, 18 year old male, had an outstanding Ramey warrant out of Albany PD and a warrant out of San Francisco. The warrants were confirmed, and Albany PD responded and took possession of the suspect and served both warrants. The vehicle was driven away by a family member. **H23-00896**

Miscellaneous Information: On September 2, 2023, at 11:35 am, officers were dispatched to the 200 block of Lilac to assist fire on a medical call. Fire received a medical alert from the residence and forced entry into the home. There was also a garbage can that was damaged in the process. A case was taken to document the damage to the residence. **H23-00897**

License Plate Theft: On September 2, 2023, at 2:26 pm an officer responded to the block of Scotts Valley for a report of a license plate theft. The Reporting Party/Victim, 41 year old male, advised on an unknown date at an unknown time his license plate was stolen. The plate was entered into SVS. **H23-00898**

Domestic Violence: On September 2, 2023, at 4:56 pm officers were dispatched to the 200 block of South Wildwood for a report of a husband who was assaulting his wife. Officers arrived on scene and detained 39 year old male subject (SUB). The Reporting Party/Victim (RP/V), 39 year old female, was contacted who advised she and her husband had gotten into a verbal altercation. The verbal altercation escalated with SUB forcefully pushing RP/V. RP/V desires prosecution and an Emergency Protective Order (EPO). Officers obtained an EPO signed by the on-call judge. SUB was served on scene and subsequently transported to Martinez Detention Facility. SUB declined to give a statement. **H23-00899**

Vehicle Collision/Driving Under the Influence/Possession of a Controlled Substance: On September 3, 2023, at approximately 11:17 am, Officers were dispatched to a vehicle collision involving a parked vehicle, with the driver attempting to leave. Officers located a black 2017 Ford Fusion that had collided with a parked 2015 Nissan Rogue and white 2014 Toyota Tacoma. The driver showed obvious signs of being under the influence of alcohol and was also uncooperative. The driver, 50 year old female of Discovery Bay, was unable to perform Standard Field Sobriety Tests due to her noncompliance and refused a Preliminary Alcohol Screening. She was unable to stand and had an odor of alcohol emitting from her person. The subject (SUB) was taken into custody for Driving Under the Influence. The Ford

Fusion was towed. During an inventory search of the vehicle, suspected Fentanyl was located in the glove box of the Ford. SUB was transported to HPD where a blood tech took her blood. SUB was cited and released to her husband. **H23-00900**

Outside Assist Supplement/ Driving Under the Influence related Traffic Collision: On September 3, 2023, at approximately 3:14 pm, an Officer entered onto eastbound Highway 4 from John Muir Parkway. The Officer observed vehicles stopping abruptly and a large amount of smoke. The Officer then observed a Blue Honda Civic driving on eastbound Highway 4 with major damage to the front and rear driver's side of the vehicle. Both tires were blown and the rims heavily damaged. The driver continued approximately 200 yards from where the Officer initially observed him and yielded once the Officer positioned their patrol vehicle behind his vehicle and when his rear wheel came off. The driver, 29 year old male out of Chico, was contacted and showed obvious signs of being under the influence of alcohol, not knowing he had just wrecked his car into a pole on the side of the freeway. CHP arrived and conducted Standard Field Sobriety Tests. The Preliminary Alcohol Screening Device indicated SUB was over the presumptive limit for the purposes of driving.
