Warrant Arrest: On September 5, 2023, at approximately 8:16 AM, an Officer conducted a pedestrian stop on 22 year old female out of Somerset. The subject (SUB) had an outstanding warrant for her arrest out of Clearlake PD. SUB was transported to Martinez Detention Facility and booked on the warrant. **H23-00902**

Possession of a Loaded Firearm X2/ Possession of an Unregistered Firearm: On September 5, 2023, at approximately 1:34 PM, an Officer conducted a traffic enforcement stop on a black 2020 Dodge Charger for various vehicle code violations. The 26 year old male driver, out of Tracy and Rodeo, was contacted. Marijuana violations were observed inside of the Charger and the Charger's registration expired on 09-2022. The Officer elected to conduct a probable cause search of the Charger and requested a tow truck for the violation of expired registration. A search was conducted, and a handgun was located in a bag hidden under the front passenger seat. The firearm was registered to the subject (SUB). Located in the trunk of the Charger was a handgun that had no record or registration on file. A rifle magazine was also located in the backpack. SUB was arrested on multiple firearm related charges and booked at Martinez Detention Facility. **H23-00903**

Estes Robbery: On September 5, 2023, at approximately 2:42 PM, Officers were dispatched to Home Depot regarding a theft in progress. The Reporting Party stated the suspect was fleeing in a white Chevrolet Impala. An Officer located the vehicle, and the suspect exited the Impala and was quickly detained. The suspect, 34 year old male out of Pittsburg, was found to have an outstanding warrant issued by San Mateo SO. Follow up at Home Depot determined the subject (SUB) was approached by employees for not paying for items. SUB threw an electric saw at one of the employees, striking them and fled. SUB was arrested on his outstanding warrant and Estes PC 211 charges. SUB was transported to Martinez Detention Facility. **H23-00904.**

Assault with Deadly Weapon: On September 6, 2023, at 4:21 AM, officers responded to Safeway gas, 4000 San Pablo Ave, for a welfare check on a man lying on the sidewalk. Officers located the victim (V), 53 year old male transient, laying on the sidewalk with bleeding on the back of his head. Medics responded to treat V who stated he was struck with a pipe like object in the back of the head at an unspecified location, possibly Willow or Parker Ave. V stated he was struck by an adult male accompanied by another adult male, associated with a dark colored, possible Chevrolet, pickup with a camper shell. Officers responded to the 800 block of Willow Ave, where they observed a truck similar in description parked there earlier in the night. The truck was located, and the occupants were contacted and identified, but could not be tied to the alleged crime without further information. V's statement was inconsistent with his injuries and the distance he said he walked. Officers looked all over shopping centers and sidewalks from the Rodeo border to V's location and were unable to locate a crime scene or any associated evidence. A check on FLOCK did not reveal any vehicles matching the description during the time frame of the incident. An officer

followed AMR, who transported V to the County Regional Medical Center, to obtain a more detailed statement from him. **H23-00905**
