**Mental Health Evaluation Hold:** On September 6, 2023, at 1:07 PM officers were dispatched to the BART lot, 1375 Willow Avenue, for a report of a male talking to himself and waving around a knife. Officers contacted a 30 year old male subject (SUB) who was yelling incoherently while armed with a knife in his hand. Officers ordered SUB to drop the knife and take a seat on the curb. SUB was compliant and detained without incident. SUB was transported to the County Regional Medical Center by AMR after being determined to be a danger to himself and others. The knife was taken for destruction. **H23-00906**

**Stolen Vehicle:** On September 6, 2023, at 1:34 PM, officers were dispatched to The Grand Apartments for a report of a stolen vehicle. The Reporting Party/Victim (RP/V) advised her black Nissan Maxima was stolen on an unknown date and an unknown time. RP/V advised she had parked her vehicle on the 2200 block of John Muir Parkway on 09/04/2023 at an unknown time. RP/V noticed today her vehicle was missing. The Nissan was entered into SVS. An area check was conducted for the Nissan, but the vehicle was unable to be located. **H23-00907**

**Towed Vehicle:** On September 6, 2023, at 3:40 PM an officer was dispatched to the 100 block of Trellis for a report of an abandoned vehicle. A license plate for an Acura TL was provided. Officers responded and determined the vehicle's registration was expired as of 12/2022. The vehicle was towed. **H23-00908**

**Domestic Violence, Elder Abuse, Possession of Loaded, Unregistered Concealed Firearms x3:** On September 6, 2023, at 5:09 PM officers were dispatched to the 800 block of Willow Avenue for a report of a man attacking a woman. Officers contacted a distraught, bleeding woman who was the 65 year old Reporting Party/Victim (RP/V). RP/V was sobbing, complaining of pain, and bleeding from her face. RP/V advised her 63 year old husband punched her in the face and body after an argument. RP/V stated she jumped out of the subject's (SUB) red Toyota Tacoma to prevent him from harming her further. SUB then fled the scene in his vehicle. As officers obtained a statement from RP/V, SUB returned to the scene. SUB was promptly detained without incident. SUB was arrested after it was determined through RP/V's statement and apparent injuries that SUB was the dominant aggressor. Under Miranda, SUB advised he had three firearms in the Toyota. The vehicle was searched yielding the recovery of two rifles and one pistol. All the firearms were unregistered and not in a locked container. The firearms were seized as evidence. The Tacoma was inventoried and towed. SUB was transported to Martinez Detention Facility. RP/V refused an Emergency Protective Order and declined to be seen by medical personnel. **H23-00909**

**Warrant Arrest:** On September 6, 2023, at approximately 2:10 AM, an Officer contacted a 45 year old male, out of Hayward, in front of the Grand apartments. A records check determined the subject (SUB) had an outstanding warrant issued by Sunnyvale PD and Solano SO. Both

warrants were non-citable, and SUB was transported to and booked into Martinez Detention Facility without incident. SUB was also found to be a missing person and was removed from MUPS. **H23-00910**
