<u>Theft:</u> On September 6, 2023, at 1:36 pm, an officer was dispatched to Lucky for a possible theft from a person. The victim told the officer she wished to press charges and file a police report. Case taken for theft <u>H23-00911</u>

<u>Warrant Arrest:</u> On September 7, 2023, at 4:32 pm, an officer conducted a traffic stop on a vehicle for a vehicle code violation. The officer contacted a 40 year old male, who had an outstanding warrant. He was arrested, cited, and released. <u>H23-00913</u>

<u>Grand Theft:</u> On September 7, 2023, at 5:57 pm, officers were dispatched to Home Depot for a theft in progress. Employees stated a subject was putting items in his pants and was about to leave the business without paying for the items. Officers contacted a 40 year old male, who had over \$1000.00 of merchandise in his pants. The subject was also found to have been served with a no trespass form, from the business. He was arrested and transported to the Martinez Detention Facility for Trespassing and Grand Theft. <u>H23-00914</u>

Home Invasion: On September 8, 2023, at 9:25 am, officers were dispatched to a report of a male and female fighting on the porch of 100 block of Paradise Dr. When Officers arrived on scene no one was located at the residence, but broken glass and blood was located in front of the unit. A neighbor confirmed a possible robbery had occurred, and the adult male suspect may have been armed. Officers made entry into the residence, to conduct a protective sweep for possible victims, and no one was located. The victim, and her son, arrived on scene. The victim confirmed an armed robbery had occurred and the suspect was and unknown adult male. The investigation is continuing. **H23-00915**

Possession of Assault Rifle, Felon in Possession of a Firearm, Felony Domestic Violence, Child Endangerment, Preventing a 911 call, Criminal Threats, False **Imprisonment:** On September 8, 2023 at 9:28 AM officers were dispatched to the 100 block of Hawk for a report of a domestic violence. The reporting party stated her 18 year old daughter called her. The daughter said she was being assaulted by her 20 year old boyfriend. The incident was occurring at the residence on Hawk. The victim told her mother the suspect was refusing to allow her leave the house and take their 20 day old infant child. Officers arrived on scene and established a perimeter around the home. Announcements were made, for several minutes, requesting all occupants exit the residence. No response came from the occupants; however, movement was seen in several windows. After several minutes of additional announcements, with no response, an officer breached the front door. The officer again requested the occupants to exit. After several minutes a 20 year old male, later identified as the suspect, exited the home advising no one else was in the home. The subject was detained. Several more announcements were made and a 18 year old female, later identified as the victim, with an infant, exited the home. The victim had swelling, bruising, and lacerations to her face. The child appeared to be uninjured. Several additional announcements were given. Two males, 18 and 19, exited the residence and were detained.

Officers made entry and cleared the home determining it was unoccupied. The victim was interviewed, and it was determined the suspect had slapped, pushed, strangled, and threatened to kill her. The victim further informed officers the suspect has a gun somewhere in the home. A Records check determined the suspect is on searchable felony probation for assault with a deadly weapon. A probable cause/probation search was conducted which resulted in the discovery of a short barreled, un-serialized rifle, with a 40 round magazine. The 18 and 19 year old males were interviewed and released. The suspect was arrested and transported to the Martinez Detention Facility. An Emergency Protective Order was granted, and the suspect was served. **H23-00916**

<u>Stolen Vehicle Recovery:</u> On September 8, 2023 at approximately 9:28 PM HPD received a Flock hit on a gray 2017 Toyota Rav4 in the area of EB Willow/Cambridge. HPD Officers located the Toyota, unoccupied, parked in the 700 block of Seacliff Ct. **Case 23-917**

Vehicle Theft, Possession of a Stolen Vehicle, Resisting Arrest, Possession of Concealed Dirk or Dagger: On September 9, 2023 at 2:45 PM officers were notified of a stolen Ford Econoline van driving North on San Pablo Avenue at Tsushima. Officers responded to the area and located the vehicle parked in the Safeway parking lot. A 27 yar old male was exiting the driver seat as an officer approached. A stop was initiated but the suspect fled into traffic, running west bound through North and South bound lanes of San Pablo Avenue. Another responding officer was driving North on San Pablo Avenue and observed the suspect running through oncoming traffic. The officer exited the patrol vehicle and chased the suspect, on foot, into the forested area across from Safeway. The suspect fell, as he jumped over a creek, and a concealed hunting knife, in a sheath, was observed hidden in his waistband. The suspect took an aggressive stance and refused lawful commands to get on the ground. The officer engaged his taser as the suspect continued his attempt to run away. His speed was inhibited due to the taser strike to his leg. An additional officer arrived on scene to assist with the detention and safely disarmed the subject. A Records check determined the subject is on Probation for Possession of a Stolen vehicle. The subject was arrested and transported, by AMR, to the County Regional Medical Center for evaluation before being booked into the Martinez Detention Facility. The vehicle was towed from the scene and removed from the Stolen Vehicle System. **H23-919**

<u>Collison:</u> On September 10, 2023, at approximately 1:16 PM, Officers were dispatched to an injury collision, that had just occurred, on Victoria Park at South Shelter Bay. Officers arrived and located a 27 year old female, and an 81 year old male. outside of their vehicles The male was driving in his 1992 Ford Explorer eastbound on Victoria Park. The female, driving a 2021 Jeep Wrangler, turned left from the westbound lanes, in front of the male driver. The male was transported for a minor head laceration. **Case 23-00920**

<u>Warrant:</u> On September 10, 2023, at 8:33pm, an Officer conducted a traffic stop, in the area of Country Run and Refugio Valley Rd, on a White 1998 Lexus ES 300, for vehicle code violations. The 57 year old male driver, of Hercules, was found to have a non-citable felony warrant, held by San Joaquin County SO. The subject was arrested and transported to the Martinez Detention Facility. **H23-00922**

<u>Vandalism/Negligent Discharge of a BB Gun:</u> On September 10, 2023, at 9:21pm. HPD Officer were dispatched to the 100 block of Agate Way, for the report of shots fired. The reporting party stated a suspect, driving a blue Toyota Prius with driver door damage, just fired shots into his home. The vehicle was last seen driving "down the hill". An Officer located a Prius, matching the suspect vehicle description, turning onto west bound Sycamore Ave, from north bound Turquoise Dr. A stop, of the vehicle, was conducted and the 21 year old male driver, of Oakland, was taken into custody. The investigation; determined the driver

used a paint ball gun to shoot at two homes located in the 100 block of Agate Way. The paint balls struck different areas on the home, causing damage to both. A functional, loaded, paint ball gun was found behind the front passenger seat of th Prius. The subject driver was arrested, cited and released on two Misdemeanor offenses. **H23- 00923**

<u>Towed Vehicle:</u> On September 11, 2023, at approximately 9:05 AM, an Officer conducted a traffic stop on a 2002 Mercedes Benz CLK 320. The Officer recognized the Mercedes as the same vehicle that fled from him last week. The 21 year old male driver, of Concord, was contacted. He stated he has not updated his registration. The Mercedes' registration expired in July, 2022. The Mercedes was ultimately towed pursuant to the registration violation. **Case H23-00924**

<u>Lost Property:</u> On September 11, 2023, at approximately 2:12 PM, A adult Hercules resident advised he shipped his rifle to company to have worked done on it. The company sent it back through FedEx. However, the gun was sent to the wrong person. in Illinois. The person apparently signed for the package and kept the Rifle. FedEx and the company both say there is nothing that can be done to get the rifle back and neither company accepts responsibility for the mislabeling. The rifle was entered into Automated Firearm System. **Case 23-00925**

Robbery: On September 11, 2023, at 10:20 pm, officers responded to the 1000 block of Baywood Lane for a report of a 61 year old female, who was robbed, of her purse, at gun point. Two males, wearing hooded sweatshirts, were last seen fleeing on foot down the alley way toward Willet St. Officers arrived in the area and conducted area checks of all surrounding areas, close by neighborhoods, and apartment complexes, but were unable to locate the suspects. The victim stated she was arriving home, from SFO, and was getting out of her vehicle. She was approached by the two subjects and one subject produced a handgun. The subject with the gun took her tote bag off her right shoulder. Both subjects fled on foot. The loss was cash, bank cards and identification. **H23-00926.**
