<u>Mental Health Evaluation</u>: On September 12, 2023, at approximately 12:20 PM, Officers were dispatched to the 1200 block of Taraya Terrace for a random female who had walked into the someone's residence and then walked out. Officers arrived on scene and determined no crime occurred. Officers located the 26 year old female, of Berkeley, on the trail at Frog Pad Park. The subject was determined to be a danger to herself and others and was taken, by AMR, to County Regional Medical Center for evaluation. **Case H23-00927**

<u>Stolen Vehicle:</u> On September 12, 2023, at approximately 1:31 PM, a 40 year old male arrived at the Hercules Police lobby to report his vehicle stolen. His black, 2002 Chevrolet Silverado was last seen last night on September 11, 2023. A Flock search revealed the last activation for the truck was at 2:55 AM on San Pablo Ave towards Pinole. **Case H23-00929**

Possession of a Controlled Substance/Probation Violation: On September 12, 2023, at approximately 4:56 PM, an Officer conducted a traffic stop on a 2005 Ford SUV. The 41 year old male driver, of San Pablo, was contacted and found to be on Contra Costa Formal Probation. There was drug paraphernalia in plain view. A probation/probable cause search was conducted of the Ford. The Officer located suspected Methamphetamine and drug paraphernalia inside. The subject was arrested, cited, and released on scene for possession charges and probation violation. **Case H23-00930**

Residential Burglary: On September 12, 2023, at approximately 5:33 PM, Officers were dispatched to the 1200 block of Willow Ave for a report of a Burglary. Officers observed forced entry to the front door and cleared the residence for any outstanding suspects. No suspects were located. The 26 year old female victim advised that her sister, who is also a resident, left the home at approximately 9:00 AM on this date. The victim returned home at approximately 5:00 PM and observed the forced entry and contacted the police. The victim stated the loss was clothing, cash, various electronics, and her Pitbull puppy. **Case H23-00931**

Mental Health Detention: On September 12, 2023, at 8:21 pm, officers responded to the Hercules Transit Center for a female subject who refused to get off the bus. Upon arrival, officers contacted a 29 year old female, on the bus. The subject complied with orders to get off the bus, but once outside, she appeared to be suffering from mental health issues. Based on the subject's actions and statements, she was determined to be gravely disabled and transported, by AMR, to the County Regional Medical Center for an evaluation. **H23-00932.**

Domestic Violence: On September 12, 2023, at 11:19 pm, officers responded to the 1200 block of Hercules Ave for a report of a woman claiming she was pushed down by a man. Yelling could be heard in the background. While in route, the victim called back to say she did not need help. Officers proceeded to the call and spoke with the victim, outside the residence. The subject stated that she and her 58 year old Finance were arguing, and he

pushed her. Thea victim did not have any visible injury and declined medical. Officer contacted the male subject at the front door and detained him without incident. After further interviews and investigation, it was determined there was insufficient evidence to support probable cause for an arrest. The victim declined prosecution and a Emergency Protective Order. She left to stay with a friend for the evening. A case taken for documentation purposes **H23-00933**.

Trespassing / Obstructing and Delaying: On September 13, 2023, at 1:28 am, officers responded to Jack in the Box for a report of an unwanted adult male subject in the dumpster acting aggressive towards employees. Officers contacted the 36 year old male by the dumpster. The subject refused to comply with the officer's instructions, shouted profanities and attempted walk away. The subject was detained without incident and Jack in the Box employees signed a Complainant's Arrest Form for him. The subject was transported to the Martinex Detention Facility **H23-00934.**
