Prisoner Transport: On September 19, 2023, at 11:45 am, an Officer responded to Santa Rita Jail to pick up a 33 year old male. The subject was arrested for an outstanding Failure to Appear warrant. Upon pick up he was transported to Martinez Detention Facility without incident. **H23-00957**

Miscellaneous Information: On September 20, 2023, at 1:49 pm, officers responded to the 1800 block of Redwood Road for a report of a 43 year old male party (P1), calling in to report his wife, 43 year old female party (P2), attempted to strangle him with an extension cord but refusing medical. While in route, P1 called back stating he did not want to press charges, he just wanted police to scare her. Officers contacted P1 who stated P2 attempted to strangle him with an iPhone cord. P1 did not have any symptoms, signs or marks from strangulation and was inconsistent with his story. Medics responded but P1 refused aid. P1 denied any physical altercation between them, but stated they were involved in a verbal disagreement in which she requested P1 to leave. P2 also stated, P1 is suffering from paranoia issues and his behavior is getting increasingly worse. P1 retrieved an iPhone cord which had the charging end broken off and claimed it broke during the alleged strangulation, however the damage to the cord was not consistent with it being used as a strangulation tool. The strangulation was unfounded and P1 was given a courtesy transport to avoid further conflict. Case taken for documentation only. **H23-00958**

Occupied Stolen Vehicle Recovery Supplement: On September 20, 2023, at 1:00 pm officers received a FLOCK notification of a stolen Black Nissan Maxima traveling West on Sycamore Avenue at the clock tower. An officer located the vehicle and initiated a high risk stop in front of the Legends Studio. The driver of the vehicle, 61 year old female, was detained. It was determined the subject (SUB) is the registered owner of the vehicle and had found her own vehicle shortly after reporting it stolen. The vehicle was removed from the Stolen Vehicle System and SUB was released. A supplemental narrative was taken for the recovery. **H23-00907**

Warrant Arrest: On September 21, 2023, at 2:04 am an officer conducted a pedestrian stop in the area of San Pablo Avenue and Linus Pauling. The individual contacted was identified as a 32 year old male from Pinole. The subject had a non-citable warrant out of Solano County. He was arrested and transported to Martinez Detention Facility. **H23-00959**

Warrant Arrest: On September 21, 2023, 3:28 am an officer contacted a 31 year old female from San Francisco. The subject had a non-citable warrant from Beverly Hills. She was arrested and transported to Martinez Detention Facility. **H23-00960**

Injury Vehicle Collision: On September 21, 2023, at 8:12 am an officer was flagged down regarding a four-vehicle collision with injury near Willow Ave at eastbound I80 on ramp. All parties were outside of their vehicles. A 19 year old male driver (D1) had an injury to his nose

and a 20 year old female passenger (Pass 1) was bleeding from her forehead, nose, and mouth. All other parties did not have any injuries and were medically released at the scene. D1 was uncooperative but ultimately said he was driving just over 35 MPH when he saw an Acura merge into his lane, he then slammed on the brakes to avoid the collision however his Honda collided with a 2012 Acura. The Acura then collided into a 2015 Toyota which subsequently collided into a 2020 Toyota. All the other parties stated they were stopped at the red light when the collision occurred. Pass 1 stated she was wearing her seatbelt with the lap belt across her, but the shoulder harness was tucked behind her. She was transported to the hospital. D1 was transported by his mother to be evaluated. The Honda was towed. **H23-00961**

Lost Property: On September 21, 2023, at 10:00 am an officer was dispatched to the 100 block of Oriole Court for a report of a lost wallet. The Reporting Party (RP), 83 year old male, stated sometime between yesterday and today, he lost his wallet at either Kinder's or Rite Aid in Hercules. RP's California Driver's License was added into Automated Property System as lost. **H23-00962**

Driving On Suspended Driver's License with Prior Driving Under the Influences (DUIs): On September 21, 2023, at 9:58 am an officer observed a 2004 grey Honda Accord with expired registration. The officer conducted a traffic stop on eastbound I80 on ramp from Willow Avenue. The officer contacted a 31 year old male subject (SUB). A records check was conducted which determined SUB had a prior DUI, had a driver's license suspended for DUI and was on San Francisco County probation for DUI. SUB was cited and released on his written promise to appear. **H23-00963**

Sex Registrant Out of Compliance: On September 21, 2023, at 2:26 pm, a 46 year old male arrived at the HPD lobby for his annual registration. A records check revealed he was wanted out of Contra Costa County. The subject was arrested and transported to Martinez Detention Facility. **H22-00964**

Possession of a Controlled Substance/Probation Violation: On September 21, 2023, at approximately 3:06 pm, an Officer initiated a consensual encounter on a 31 year old male. The subject (SUB) was on Contra Costa County probation with a search clause. SUB spontaneously stated he had methamphetamine in his pocket. A probation/probable cause search was conducted, and the Officer located suspected Methamphetamine and drug paraphernalia on his person. SUB was cited and released on scene for possession charges and probation violation. **H23-00965**

Property Damage Collision: On September 21, 2023, at 4:16 pm, officers were dispatched to a report of a loud crash in the area of Turquoise Drive near Crystal Circle. The Reporting Party (RP) informed dispatch that a white Nissan Altima hit a light pole near the Senior Center. An officer determined the driver, 58 year old female, failed to maintain her lane due to dozing off while driving and seared a city light pole from its base. No electrical wires were exposed. Public works was contacted. **H23-00966**

Lost/Stolen Plate: On September 21, 2023, an officer responded to the 1000 block of North Shelter Bay for a report of a lost or stolen license plate. The Reporting Party/Victim (RP/V), 36 year old female from Hercules, stated on September 20, 2023 at approximately 7:00 pm she noticed her rear license plate from her Mercedes was missing. The plate was entered into the Stolen Vehicle System. **H23-00967**

Collision: On September 22, 2023, officers responded to the area of 2200 Forest Run for an automated report of a collision. Dispatch contacted the phone number provided and spoke to

a 52 year old female subject (SUB) from Hercules. Officers arrived for a welfare check and located a gray Toyota Camry with moderate damage to the rear and a Toyota Rav 4 with minor damage to the rear bumper. Officers contacted SUB who stated she had collided into the vehicles driving home for a personal emergency. The Toyota Camry's owner was contacted, and information was provided. A notification card was left for the Toyota Rav 4.

Stolen Vehicle: On September 22, 2023, at 10:04 am an officer was dispatched to the 100 block of Manzanita for a report of a stolen vehicle. The Reporting Party/Victim (RP/V), 45 year old, advised her 1996 Ford F250 was stolen sometime between 3:20 am and 10:04 am on 09/22/2023. The vehicle was entered into the Stolen Vehicle System. **H23-00970**

Battery: On September 22, 2023, at 3:50 pm officers were dispatched to the 500 block of Alfred Nobel for a report of a battery which had just occurred. Officers contacted the Reporting Party/Victim (RP/V), 42 year old female, who had visible bruising on her right eye and a laceration on both lips. RP/V advised a woman confronted her following an alleged road rage incident and proceeded to punch her in the face. RP/V provided pictures of the suspect, 36 year old female, and the license plate of the vehicle she was driving. RP/V declined to be seen by medical personnel. The suspect vehicle was a gray 2018 Dodge Ram 2500. A records check confirmed the vehicle is registered to a home in Hercules. Contact was attempted over the phone and at the residence but no answer was received. The Dodge was located parked near the home unoccupied approximately 15 minutes after the incident occurred. RP/V signed a complainant's arrest form. **H23-00971**

Hit and Run: On September 22, 2023, at 5:22 pm an officer responded to a phone detail regarding a cold hit and run which occurred on 09/05/2023 at 2:08 pm. The Reporting Party/Victim (RP/V), 68 year old male, called and advised the suspect, 78 year old male, was driving a 1998 green Toyota Camry and struck his car inadvertently resulting in a non-injury collision on San Pablo Avenue at Sycamore Avenue. Officers responded to the scene that day and attempted an information exchange. As officers attempted to make contact with the suspect, he fled the scene. The officers provided RP/V an incident number that day. RP/V came to the PD today requesting a police report and stated he desires prosecution for the hit and run. Surveillance of the incident and pictures of the damage were obtained from RP/V.

Domestic Battery, Violation of a Court Order, Parole Violation: On September 22, 2023, at 6:25 pm, Officers were dispatched to the 100 block of Paradise Drive, for the report of a domestic battery that occurred on the morning of Monday September 18, 2023. On this date the Victim (V), 47 year old female, stated that her husband, 44 year old subject (SUB), was at her apartment. SUB is on active parole out of Solano County and currently resides in Fairfield. There is currently a Restraining Order (RO) against SUB, with V listed as the protective party, however, the RO does allow for peaceful contact between the two. On the above-mentioned date, SUB was visiting V. During the visit, the two got into an argument which turned physical when SUB reportedly slapped V on her face and hit her on her back and leg with his belt. V did not immediately report the incident to police, stating that she was afraid to call. Attempts to contact SUB were unsuccessful. **H23-00973**

Theft of a Wallet: On September 22, 2023, at 7:33 pm, an Officer responded to the 100 block of Cardinal Way for the report of a theft of a wallet. The Reporting Party/Victim (RP/V), 56 year old male, stated that he unknowingly dropped his wallet in front of his home earlier this morning. While searching for his wallet, he reviewed his home's surveillance cameras to confirm his suspicion that it fell out of his pocket while he was in front of his home. At that time, he observed his wallet in front of his home. The video also showed an unknown suspect

driving a white vehicle stop in front of his home, pick up the wallet, and drive off with it. The theft reportedly occurred at approximately 9:00 am this morning. Inside RP/V's wallet was cash, his driver's license, and credit/debit cards. Since RP/V's wallet was taken, no one has contacted RP/V to return his wallet or notified him to let him know they have it in their possession. **H23-00974**

Towed Vehicle: On September 23, 2023, at 09:40 am an officer observed a 78 year old male driving a green 1998 Toyota Camry. The subject (SUB) was a suspect in a hit and run vehicle collision which occurred on 09/05/2023. The Toyota had major passenger side damage which was consistent with information obtained from the hit and run. An investigative stop was initiated, and SUB was detained. SUB was interviewed on scene and his information was obtained for the other party in the hit and run. A records check determined SUB's driver's license is suspended for multiple prior collisions. The Toyota was towed from the scene and SUB was given a ride home. **H23-00972**

Shoplifting: On September 23, 2023, at 12:20 pm officers were dispatched to Rite Aid for a report of a theft. Two unknown females entered the store and stole 4 large, laundry detergent boxes. The Reporting Party (RP), 57 year old female, recorded the incident on her cell phone and was able to obtain a picture of the suspect vehicle which was a gray 2007 Toyota Camry. Officers were unable to locate the vehicle. RP desired prosecution as a representative for Rite Aid. **H23-00976**

Mental Health Evaluation Hold: On September 24, 2023, at 10:11 am, Officers were dispatched to the area of Refugio Valley Road at Partridge Drive for a suspicious circumstance. Dispatch advised the 19 year old male subject (SUB) told them he was headed to the fire station to turn himself in. Officers located SUB walking along the entrance to the Hercules Highschool student parking lot. After speaking with SUB he was determined to be a danger to himself. As a result, SUB was placed on a 72-hour mental health evaluation hold. **H23-00977**

Towed Vehicle: On September 24, 2023, at 12:52 pm, an Officer conducted a traffic enforcement stop on a white 2006 Honda Civic in the area of Refugio Valley Road and Partridge Drive for vehicle code violations. The driver, 32 year old female, was found to be driving on a suspended license. As a result, the Civic was towed. **H23-00978**

Failed Sex Offender Registration: On September 24, 2023, at 4:01 pm, an Officer checked on a suspicious vehicle parked at the fuel pumps at 76 Gas (828 Willow Ave). The driver was contacted and identified as a 34 year old male of Vacaville. A records check of the subject (SUB) revealed that he is required to register in compliance with PC 290. SUB was found to be out of compliance and was subsequently placed under arrest. SUB was issued a citation for the violation and was released on scene on his signed promise to appear. **H23-00979**
