Guns Turned in for Destruction: On September 28, 2023, at 1:46 pm, officers were dispatched, to a Hercules residence, for a citizen who was cleaning out her father's house and located two shotguns she wished to turn in for destruction. The weapons were booked into property for destruction. **H23-00994**

Driver's License Suspension for Driving Under the Influence: On September 28, 2023, at 4:43 pm, an officer conducted a traffic stop, for a vehicle code violation, on a 2010 Mercedes. The 63 year old male driver, of Hercules, was found to have a suspended license for Driving Under the Influence. The subject was cited and released. **H23-00995**

Warrant Arrest: On September 28, 2023, at 5:14 pm, an officer checked on a Motorhome, in the parking lot of Safeway, with expired registration. The 68 year old female driver, of Walnut Creek, was found to have an outstanding No Bail warrant. The subject was arrested and transported to the Martinez Detention Facility. **H23-00996**

Vandalism: On September 28, 2023, at 12:55am, HPD Officers were dispatched to the 1000 block of Regatta Pt for a reported broken window on a Dodge Challenger. The reporting party advised nothing was taken from the Dodge and estimated it would cost \$300 to repair the window. **H23-00997**

Follow up (H23-00982) / Stolen Vehicle Recovery: On September 29, 2023, at 2:59am Vallejo PD notified HPD they located our suspect vehicle (2014 Honda Accord) for case H23-00982 (Strong Arm Robbery, which occurred on September 25, 2023). Vallejo PD advised the vehicle was unoccupied with different plates affixed to the front and rear. Both plates were reported lost/stolen to Vallejo PD on September 29, 2023. A Records check of the VIN showed the Honda was reported stolen to Sacramento PD on September 23, 2023. An Officer responded to Vallejo and a rotational Tow Company responded to tow the Honda for evidence. **H23-00982/H23-00998**

Warrant Arrest: On September 29, 2023, at 8:57 PM an Officer conducted a traffic stop at in the 800 block of Willow Ave, on a 2010 Chevrolet Malibu, for a vehicle code violation. Possession of a Controlled Substance: On September 30, 2023, at 01:01 AM a HPD Officer conducted a pedestrian stop in the 800 block of Willow Ave on a 29 year old male, of Clearlake. A probable cause search was conducted, and a baggie of suspected fentanyl was located in the subject's pocket. The subject was arrested, cited, and released **H23-01001**

Unattended Death: On September 30, 2023, at 1:23 pm, officers were dispatched to the 1000 block of Valley Run for a possible death. The reporting party called and stated he located his father deceased, and there was a Do Not Resuscitate order on file. Officer arrived on scene and located a 78 year old male deceased in the residence. The subject was released to the family by the coroner. **H23-01002**

Mental Health Evaluation: On September 30, 2023, at 9:32 PM HPD Officers were dispatched to Lucky for an unknown issue regarding a male wearing a black coat in front of the store. Officers contacted a 53 year old male, of Richmond, The subject stated he stated he called HPD on himself. After speaking with the subject, he was determined to be a danger to himself or others. The subject was transported, by ambulance, to the County Regional Medical Center for evaluation. **H23-01003**

Driving Under the Influence: On October 1, 2023, at 1:58 AM an Officer conducted a traffic stop on a Toyota Corolla, for a traffic violation, on San Pablo Ave at Victoria Crescent. The 24 year old male driver displayed objective symptoms of intoxication. He was given the Standard Field Sobriety Test. The Preliminary Alcohol Screening device indicated the subject was over the presumptive limit for the purposes of driving. The subject was arrested and later cited and released to a responsible party. **H23-01004**

Domestic Violence: On October 1, 2023, at 10:18 PM HPD Officers were dispatched to the 100 block of Coventry for a domestic dispute that occurred earlier in the night. The 43 year old female victim stated she got into an argument with her 49 year old husband. During the argument the husband pushed his wife, causing her to fall onto a baby gate. The victim sustained minor scrapes to her arm due to the fall. After the altercation husband left the residence prior to PD arrival. The victim declined prosecution and an Emergency Protective Order. The male subject was contacted over the phone who stated he was currently in a hotel. A case was taken for domestic violence and forwarded to the DA's Office. **H23-01005**
