Officers contacted the reporting party who stated her son had threatened her and was off his medication. The subject left on foot prior to the officers' arrival but was located at Sparrow and Tanager. Possession of Loaded Unregistered Firearm, Possession of a Concealed Firearm: On October 15, 2023 at 7:44 PM Officers were dispatched to a physical fight between two males in front of The Exchange apartments. Multiple callers called to advise two males were striking each other and rolling on the ground in the middle of the street. Officers arrived and observed a white 2020 GMC Sierra, parked in the middle of the road, with the driver's side door wide open. A 40 year old male was standing nearby and was detained by officers. The subject appeared to be uninjured and declined medical attention. As officers looked inside the open GMC truck for additional occupants, a loaded pistol was observed, in plain view, near the driver's side floorboards. A records check was conducted on the firearm was not registered. The firearm was seized as evidence. A 39 year old female was on scene and advised the subject is herex-husband and he had gotten into an altercation with a 38 year old male, who is her new boyfriend. The female said she did not see any physical altercation. Officers contacted the boyfriend by phone. The boyfriend left the = prior to the officers' arrival and declined being involved in any fight. He refused to return to the scene. The subject was placed under arrest, for the weapons violation, and transported to the Martinez Detention Facility. H23-01038

<u>Outside Asist for CHP – Rollover Collision:</u> On October 15, 2023 at 5:00 AM Hercules officers were advised of a solo rollover vehicle collision on Highway 80 East near Cummings Skyway. CHP was responding but their arrival time was extended. Per CHP dispatch, the driver was a mother who was trapped in the overturned vehicle. The mother advised her 1 year old and 2 year old children were also trapped in the vehicle. At this time,

injuries were unknown. Hercules officers, and Contra Costa Deputies, responded. Officers located the vehicle, approximately 20 yards off the freeway, upside down in a field. Officers and Deputies successfully extracted the two children and the mother. Officers shut down the freeway and began to conduct traffic control. The mother and her children were evaluated by medical personnel on scene. CHP eventually arrived on scene and began their collision investigation. Hercules officers utilized their drone, with thermal. imaging, to confirm there were no outstanding parties which were possibly ejected. No other parties were located. The ichildren and their mother were seemingly uninjured. All parties were transported to the hospital via ambulance, as a precaution. <u>lincident # 23-0029</u>
