Prisoner Transport: On October 24, 2023, at 9:02 am, a Parking Enforcement Officer responded to Napa County Jail to pick up a 30 year old female. The subject was arrested on an outstanding felony warrant held by Hercules PD. The subject was transported to the Martinez Detention Facility. **(H23-01057)**

Grand Theft, Conspiracy, Organized Retail Theft: On October 24, 2023, at 12:27 pm, HPD Officers were dispatched to Lucky (1590 Sycamore Ave) for the report of a theft that just occurred. The suspects were described as an adult female, with a white shirt and jeans, and an adult male. The two suspects left the store and got into a red Honda with a gray hood. The vehicle was also described as having rear passenger side damage. The suspects were last seen, fleeing the parking lot, onto eastbound Refugio Valley Rd towards Pheasant Dr. Officers conducted an area check for the Honda. The city's Flock Safety Automated License Plate Reader system was checked for the vehicle. A Honda, matching the suspect vehicle description, was captured by the system traveling eastbound on Refugio Valley Rd. An Officer located the vehicle parked along the curb on Carson St near Refugio Valley Rd. Both occupants of the vehicle matched the suspects' descriptions, and were detained without incident. They were identified as a 41 year old female, of Pittsburg; and a 58 year old male, of Pittsburg. An in-field show was conducted, and both subjects were positively identified as the suspects that stole from Lucky. The subjects were placed under arrest. Inside the Honda, over \$1,000 of stolen Lucky merchandise was located (assorted meats, laundry cleaning products, alcoholic beverages etc.). The merchandise was collected and returned to Lucky. The Honda was towed for registration violations, The subjects were transported to the Martinez Detention Facility. **(H23-01058)**

Suspended License/Towed Vehicle: On October 25, 2023 at 12:20 AM officers were dispatched to Turquoise at Crystal for a report of an unknown female trespassing in the backyard of a residence and pounding on the sliding glass door. The reporting party advised she did not know the woman and also stated there was an unknown Penske rental van parked blocking her driveway. Officers observed a 59 year old female, driving the Penske van away from the scene. A traffic stop was conducted, and the female was contacted. Her demeanor was erratic and somewhat incoherent. A records check was conducted which determined the subject was driving on a suspended driver's license. The subject was cited for driving on a suspended driver's license, and the van was towed from the scene. The subject was escorted home as she did not quite meet the criteria for a mental health evaluation .
